## Commissioner Meeting May 1, 2018

Commissioner Joel Hamar called the meeting to order at 9:30. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited.

Chairman Hamar presented the funeral brochure for Norman Andrus, former County Commissioner for Dickey County, serving the county for 16 years. Hamar stated that Andrus was always concerned with doing what was good for the county and his work was appreciated. Hokana stated he was a special ambassador at the state level and was highly respected by everyone.

Additions to the agenda State Line road Security on the Social Services building Park mower

Roberts made a motion to approve the minutes from the April 17, 2018 with changes. Sand seconded. Motion carried.

Hokana made a motion to approve all vouchers. Sand seconded. Discussion followed. The vouchers were not approved, pending review of Job Development Authority bylaws and minutes.

Clerk of Court Andi Schimke joined the meeting at 10:00.

DES/911 Coordinator Charlie, Sheriff Chris Estes, County Agent Breana Kiser, and 4-H Agent Aimee Ellinger joined the meeting at 10:25. Kiser and Ellinger gave an update on programs that they are currently working on. Kiser reported that Administrative Assistant Shirlene Wagner was recognized at the Administrative Assistant Conference last week for her 45 years of service. Ellinger informed the Commission that there will be a steak fry fund raiser on May 19<sup>th</sup> for the shooting sports to make improvements to the building so that shooting sports can continue year-round.

Sheppard presented a ND Department of Transportation Final Certification of Local Match form, to specify where non-match funds were obtained. Sand made a motion to sign the form, specifying the funds came from tax dollars in the road fund. Roberts seconded. Motion carried.

Assistant States Attorney Jeff Glynn, Highway Superintendent Jeff Hagen, SE Water Users representative Troy Bommersbach, and Tax Director Don Flaherty joined the meeting at 10:45.

The Commission reviewed comments made concerning changes to be made to the Employee Handbook changes. Commission felt the comments made where concerns that will need to be looked into in the future and doesn't affect the policies changed. The changes have been reviewed by the States Attorney, as well as a comment period for Department Heads. Simek made a motion to approve the Employee Handbook changes. Hokana seconded. Motion carried.

Flaherty reported to the Commission on the minutes of the Job Development Authority, concerning a grant and loan to the Ranch House in Fullerton.

Glynn updated the Commissioners on the FEMA payback of funds on the German Township project. Glynn felt that Pearce Durick had put together a proper draft complaint. Glynn feels that the suit will get thrown out of court. Discussion followed. Commission asked Glynn to work out the best way to go with the issue. Commission asked him to weigh all options.

Administrative Assistant Shirlene Wagner joined the meeting at 11:20. Hamar thanked Wagner for her 45 years of service with Dickey County Extension.

Bommersbach presented three Utility Permits to bore lines under County Road 3 and County Road 5. SE Water Users is requesting to bore the lines without casings. The current project does not require six-inch piping. Hagen stated he didn't see a problem with not using casings. According to Bommersbach, the State of North Dakota has waived the requirement of casings less than six inches. Simek made a motion to waive casings for lines smaller than six inches. Roberts seconded. Motion carried. Sand made a motion to approve the permits for SE Water Users. Simek seconded. Motion carried. Copies of the signed permits are on file at the Auditors Office.

Hagen presented three utility permits for Dakota Valley Electric to bore power line. Roberts motioned to approve the permits. Sand seconded. Motion carried.

Hagen stated the new disk and bobcat have arrived. Hagen stated the appraisal on the blade that is being replaced is appraised at \$110,000. Hagen had checked into placing the blade on PurpleWave, and the blades of that type are bringing \$90,000 to \$120,000, but no minimum can be put on the equipment. Hagen doesn't know when the new blades will arrive and can't afford to be without a blade. An ad will be placed on BisMan Online and a mass e-mail will be sent to all county Auditors concerning the sale of a 2013 772GP blade with snow equipment until the next meeting of the Commissioners at a price of \$120,000 or best.

Sand reported to Estes that there were residents on the State Line Road complaining of the heavy truck traffic cutting into the road, specifically large tractors coming out to 281 on the flat bed. Also there has been a lot of activity with cranes moving, specifically Sunday mornings. Estes stated they have jurisdiction a thousand feet into the state of South Dakota. The problem is west of Highway 281.

Estes will check into times it is occurring and get one of his deputies to be on the State Line Road to solve the issue.

Russell presented a Fire Emergency and Burn Ban Plan for 2018. Simek made a motion to sign the Burn Ban Plan. Hokana seconded. Motion carried.

Commissioners reviewed the bylaws of the JDA concerning awarding grants and loans to organizations in the county. A letter from Chairman Hamar will be composed to inform the JDA board about the concerns about their expenditures and a reminder as to their purpose, that the funding should be used to increase their employment or promote tourism and not for their payment of daily expenditures. A vote on the earlier motion to approve all vouchers was completed and motion carried.

Hamar stated the Commissioners had received an e-mail from AgriMax, stating they would be interested in doing work with the county. The e-mail has been forwarded to both Water Boards and the Weed Board.

Sheppard presented a ballot for the election of the ND Insurance Reserve Fund. Hokana made a motion to sign the ballot and vote by proxy. Roberts seconded. Motion carried.

Russell updated the Commission on the new access system for Social Services. Russell stated that they are waiting for badges and few missing parts. A quote had been received to change the Courthouse access in the amount of \$6,401.90. Russell stated there may be Homeland Security money for the project. Hokana made a motion to rebadge all employees for the new system. Roberts seconded. Motion carried. Installation for the courthouse will wait until HLS money is applied for and an answer received on the grant.

Sand made a motion to request an additional advance on work done on Dickey County Road 2. Simek seconded. Motion carried.

Sheppard will speak with the architect about the USDA loan and not having to complete tasks they require to complete the basement project.

Hamar presented pictures of the park mower, after it was cleaned up and the oil changed. Hamar will place on BisManOnline for \$6,750 or best offer.

Hokana made a motion to adjourn at 12:57.

## Commissioner Meeting May 15, 2018

Commissioner Joel Hamar called the meeting to order at 9:30. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited. Treasurer Gail Veland joined the meeting at 9:40.

Additions to the agenda

Dickey Co Road 5 west of Highway 11

Hamar reported that the park mower was put on BisMan Online. Hamar received one call and an agreement to sell the mower for \$6,000 was agreed upon. The check has been received.

Simek made a motion to approve the minutes from the May 1st meeting with changes. Roberts seconded. Motion carried

Hokana made a motion to approve all vouchers. Sand seconded. Motion carried

Simek made a motion to approve the Financials. Sand Seconded. Motion carried

Glynn Brothers Concrete, along with Custodians Ray Peterson and Scott Peterson joined the meeting at 10:00 to discuss the roof drain on the east side of the Courthouse. There will be a lake in the grass if the project is not completed to the street. They would put a concrete gutter that is three feet wide to the sidewalk. The estimated cost would be \$2,500 to \$3,000. Ray is concerned about the sprinkler lines there. They would have to dig a little deeper by the current line so the irrigation lines are not affected. The grass is the same height of the sidewalk for 31 feet. Other options were discussed. Glynn will contact the city about cutting the curb for the drain before any cutting is done. Simek made a motion to approve the drain to the street. Roberts seconded. Motion carried.

Deputy Auditor Stormy Bertsch presented a temporary liquor license for a wedding dance on August 4th at Guelph Community Center from The Black Pelican. Sand made a motion to approve the liquor license. Hokana seconded. Motion carried.

Tax Director Don Flaherty joined the meeting at 10:14 to talk about the Omitted Tax Hearings for the June 5th meeting. There will be four separate hearings. The County Equalization meeting is June 7th at 1:00 in the Courtroom.

Mitch and Scott Roney joined the meeting at 10:17 to discuss their animal feed lot application for a 1,500 animal hoop barn and feeding facility. The size of the building would be 400 x 70 feet wide for cows. Roneys have been working with the Department of Health, as this also needs to be approved by them. Roney stated they have checked with their neighbors and there all seem to be good about the building. The closest neighbor is about half mile and they do not have a problem with the new building. The Department of Health needs the preliminary minutes showing the Commission approve the application. Roberts made a motion to approve the application for the feed lot pending a release letter

to the property owners within a 3/4 mile radius of the feed lot showing support for the building. A letter will be sent out by the Auditor's office with the approval form for their signature. Hokana seconded. Roll call vote with Sand yes, Hokana yes, Roberts yes, Simek yes Hamar yes. Motion carried. DES/911 Coordinator Charlie Russell joined the meeting at 10:30.

Risk Manager Cresta Miller joined the meeting at 10:40 to discuss a Law Enforcement Authority policy she had received from Workforce Safety Insurance. WSI would like the policy in all employee manuals. Roberts stated he felt the policy was fine.

Highway Superintendent Jeff Hagen and KLJ Engineer Chad Peterson joined the meeting at 10:52. Peterson presented the Structural agreement for the sealcoat projects on County Road 3 and County Road 2. The project should start the middle of July and take up to 4 weeks to do the work. The original has been adjusted from \$13,900 on the original agreement to an amount of \$69,400.00. Sand made a motion to approve the amended agreement. Simek seconded. Motion carried.

The bid opening for the bridge project is set for October. Hagen stated the detours would be about 8 to 10 miles. Hagen stated that the detour roads would work fine as the roads are in good shape.

The cost to fix County Road 3 east of Oakes would cost approximately \$250,000. Peterson stated they could look into milling a half inch off. Hagen stated the base of the road is good so milling the road would work well. Hamar requested to have the 3-year plan brought in at the next meeting to relook at the project.

Roberts asked Hagen about County Road 5 west of Highway 1, which he says is shy of gravel. Hagen is aware that it really needs gravel. Hagen will look into the gravel list to make sure it is on the list and he is waiting for road limits to come off.

Hagen presented a utility permit form from SE Water User who are wanting to bore under the road for a house going up at SE ½ 21-131-60 and NE ½ 131-60 on County Road 3. Sand motioned to approve the permit. Simek seconded. Motion carried.

Potsdam Township is requesting for culvert cost share for township culverts. Hagen stated he will look at the size of culverts and is waiting until the water board approves it. It is a township road so the cost would be 1/3 of our cost if approved by the Water Board.

Hokana made a motion to adjourn the meeting at 11:40.
