## Commissioner Budget Meeting July 10, 2018

Commissioner Joel Hamar called the meeting to order at 9:05. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited. Treasurer Gail Veland and Deputy Auditor Stormy Bertsch joined the meeting.

Risk Manager Cresta Miller joined the meeting at 9:14 to review the Risk Manager budget. There is a need for evacuation ladders for some offices in case of a fire and ergonomic desks to update current office furniture.

Veterans Service Officer Gary Dathe joined the meeting at 9:23 to review the Veterans Service Officer budget. Dathe stated that the Veterans van is being used and the county continues to be reimbursed for their expenses.

County Agent Breanna Kiser and 4-H Agent Aimee Ellinger joined the meeting at 9:35 to review the budget for 4-H Achievement, 4-H Agent, County Agent, and Extension. With the change in the calculation of the cost to the county for the 4-H Agent and the County Agent, there is an increase in the county portion of the salaries for these two positions. The County is now paying 40% of the salary and any benefits provided to the employee. In prior years, the county paid 50% of the salary only.

Veland reviewed the budget for the Treasurer's office.

Assistant States Attorney Jeff Glynn and Administrative Assistant Holly Hokana joined the meeting at 10:30 to review the States Attorney budget.

The meeting went into recess at 11:05 and reconvened at 11:15.

Weed Board Secretary Amy Sand, Weed Officer Terry Weis, Weed Board Chairman Brandon Carlson, and Weed Board member Mark Bobbe joined the meeting at 11:15 to review the Weed Board budget. Discussion followed concerning the percentage the landowner pays for the cost share program for chemical and whether the percentage of 30% should be increased. With the increased use of the chemical cost share program and the cuts in state funding that have occurred are making it hard to carry their expenses for the year. Secretary Sand will forward information to Sheppard about the amount of chemical sold to landowners in 2017.

The meeting went into recess at 12:15 for lunch and reconvened at 1:15.

DES/911 Coordinator Charlie Russell joined the meeting at 1:15 to review the budgets for Disaster Emergency, 911, County Hazard, and Homeland Security. Discussion followed concerning expenses of the sheriff's department that should be covered by 911 funds, as those same fees are being paid for the city of Oakes and Ellendale for the same service through 911 fees.

Custodial staff Scott Peterson and Ray Peterson joined the meeting at 2:00 to review the Custodian budget. Staff will get back to Sheppard when they receive the quote for repair of the water pressure issue at the Courthouse. The drain on the east side of the Courthouse was also discussed. Simek will speak with Glynn Brothers about what can be done to fix the drain.

The chip seal project for 2019 is projected to use federal funds to assist with that project.

Water Board Chairman Don Zimbleman joined the meeting at 3:30 to review the Yorktown Maple Improvement District, Dickey County Drain #1, Oakes Pilot Drain, and the Water Board budgets.

Discussion followed concerning the change in the law for the cost of drain projects into ditches. The county can only charge the landowner for \$150, while incurring significantly more costs to have the studies required to approve or disapprove the drain.

Hokana made a motion to adjourn the meeting at 4:20.

## **Budget Commissioner Meeting July 12, 2018**

Commissioner Joel Hamar called the meeting to order at 9:00. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited.

Clerk of Court Andi Schimke joined the meeting to present the Clerk of Court, Community Service, and Grant budgets. Schimke will apply for a 75%/25% Grant with Court Services in 2019 to replace the current microphone system in the court room in the amount of \$12,431.19.

Social Services Director Angie Rall, Health District Administrator Roxanne, and Administrative Assistant Amber Kingzett joined the meeting at 9:25.

Rall presented the budgets for Social Services, Economic Assistance, Family Focus, and Designated Funds. Funding from the state of North Dakota will not cover the cost of Social Services for 2019. Money from the General Fund in the amount of \$153,000 will need to be used to fund Social Services. Rall stated that the two automobiles they have has assisted in the decrease of the cost of travel to the budget. Discussion followed about the possibility of having a car for other departments other than the Social Services car for the needs of other county employees and the meetings they attend.

Holm presented the budget for Health District. The difference in board salaries between Social Services and Health District was discussed. The cost of immunizations is hard to predict or the cost for the next year.

Schimke rejoined the meeting at 10:30 to update the Commission on the Grant line item of her budget. After talking with her Court Administrator, she decreased the amount of the 75/25 grant to \$9,806.48, as some of the items on the original quote are already slated to be replaced by the state of North Dakota.

Roberts made a motion to recess the budget meeting at 10:35 for a Park Board meeting. Sand seconded. Motion carried.

The Budget meeting reconvened at 11:00.

Park Chairman Cary Wertz and Park Board member Robert Schmidt joined the meeting to present the Park Board budget. Several grants were discussed for projects on county park property. Projects were reviewed. Phase III of the beach project at Pheasant Lake could not be included in the budget for 2019, as it was significantly higher than possible for the mill traditionally collected for the Park Budget.

Fair Board Chairman Kacey Holm joined the meeting at 11:45 to present the County Fair budget. Holm stated he would have a better idea on the income from the County Fair after the weekend. Dicky County Fair starts today, July 12<sup>th</sup> and runs through the weekend.

The Budget meeting went into recess for lunch at 12:10 and reconvened at 1:05.

Recorder Deborah Anderson joined the meeting to present the Recorder and Document Preservation budgets. Anderson is requesting assistance from the Commissioners to digitize her records in her vault. Their records go back to 1882 and are becoming very faded. Anderson is budgeting to replace the canvass covers on several of the old books to protect them. The cost to digitize the records in LaMoure County was approximately \$81,000. There would also be an additional charge to download the images into the Recorder package. The Document Preservation Fund will have approximately \$40,000 at the end of 2018. The Commission stated they would be willing to set aside money for that purpose.

Tax Director Don Flaherty joined the meeting at 1:25 to present the Assessor, Tax Director, and Detailed Soils budgets. Regional training for Tax Directors is in Bismarck in 2019. Flaherty stated the budget includes travel for Flaherty and his deputy, Denise Olson to attend.

Sheriff Chris Estes joined the meeting at 1:30 to present the Sheriff, Truck Regulatory, 24/7, and Capital Projects budgets. The Sheriff's budget includes the trade in of a deputy car and the purchase of a new car.

Hokana motioned to adjourn the meeting at 2:30.

County Agent Breana Kiser, ND Department of Health representative Brady Espy, and North Dakota Livestock Alliance member Scott German Joined the meeting at 10:05.

Commission requested an updated from Kiser on the County Fair. Kiser stated the fair went well. The static exhibits and the livestock barn were full. There was a good audience for the style show on Sunday.

Treasurer Gail Veland and Sheriff Chris Estes joined the meeting at 10:10.

German explained to the Commission that the ND Livestock Alliance is a combination of all livestock commodity groups working together, to try bring more livestock into the state of North Dakota. Discussion followed concerning the decrease in pork and dairy production in the state. German stated the inability of corporate farming has significantly hurt the dairy industry in North Dakota. The alliance would like to be a liaison for the county and the landowner. Discussion followed about the county feed lot zoning ordinance that is in place. Espy spoke of the requirements of his office that all feed lots need to complete to be approved for operation. The ultimate goal for the Alliance and the Department of Health is to make the process more fluid for all involved. The Alliance is working to develop reference sheets showing state regulations, as well as other funding options that may be available to the producer.

Veland presented her treasurer's report for 2<sup>nd</sup> Quarter 2018. Sand motion to approve and have Hamar sign the quarterly report. Roberts seconded. Motion carried

Highway Superintendent Jeff Hagen joined the meeting at 10:55 am. Hagen presented 6 utility permits from Wanzek Construction for the new wind project for their substation and OMI building. The permits are for Section 1-130-66 on 91<sup>st</sup> Street and for Section 7-130-65 on 72<sup>nd</sup> Avenue through Dickey County #5. Simek made a motioned to approve and sign the permits. Hokana seconded. Motion carried.

Hagen received a phone call concerning Wanzek Construction using roads other than County Road 2, as requested. Hagen allowed them to use County Road 2. Hagen received an e-mail confirming the conversation.

Sand received a phone call this morning that another child care provider is closing in Ellendale. This is a big issue for the county, as employees do not have a place to take their children.

Sheppard presented a revised liquor license approved by the Commission earlier for the Ranch House for July 28<sup>th</sup> at 4:00 pm through July 29<sup>th</sup> at 2:00 am, as the name of the managing changed due to a change in staff. Roberts made a motion to approve the license. Simek seconded. Motion carried.

Hamar updated the Commission on the 5 County meeting held July 12<sup>th</sup>. Representatives from NDSU Extension presented to the members on the current state of the Extension department at NDSU and what the county agents are currently doing. There was also a discussion on the sales ratios from the state level for residential and commercial. There is also pending Opioid litigation that was discussed. There was also discussion concerning the cost of drain tile applications discussed with the water board during their budget meeting with the Commissioners.

Hamar stated that the committee nominated Sherry Hosford for the Excellence in County award. Sheppard will send a letter on behalf of Dickey County to ND Association of Counties concerning the assistance received by Dickey County from Sherry Hosford in the past years as the Sargent County Auditor and now as the Secretary for the Dickey Sargent Joint Water Board. The next 5 County meeting will be October 4<sup>th</sup> in Sargent County.

Risk Manager Cresta Miller joined the meeting at 11:55 to update the Commission concerning an e-mail she received from the state of North Dakota concerning grant money for ergonomic items the county could use. All options are free. Commission stated that they felt Miller knew best where the items were needed and what would be best.

The meeting went into recess for lunch at 12:05 and reconvened at 1:15.
