Commissioner Meeting October 1, 2019

Commissioner Joel Hamar called the meeting to order at 9:00. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited.

Hamar recognized Highway Bookkeeper Glenn Pahl for his years of service with Dickey County. Pahl worked for Dickey County starting part time in 1966 and took on the bookkeeper position in 1982. The Commission appreciate his many years of service to Dickey County

Sand made a motion to approve the minutes from September 17th with corrections. Roberts seconded. Motion carried.

Sand made a motion to approve the vouchers, removing the duplicate payment to the Office of the State Auditor and a reimbursement check to the Dickey County Water Board. Hokana seconded. Motion carried.

Simek made a motion to appoint County Agent Breana Kiser as the State Fair annual meeting delegate for Dickey County. Hokana seconded. Motion carried.

Social Services Director Angie Rall, Sheriff Chris Estes, and Administrative Assistant Andrea Masse joined the meeting at 9:35.

Rall presented the Social Services Zone agreement for signature by Commissioner Hokana, as he one of the representatives for Dickey County on the South Country Human Services Zone Board. There has been a small change in the contract, which is filed with the Department of Human Services for their approval of the zone agreement. Discussion followed concerning the addition of the requirement of the county getting approval from the State concerning hiring and/or firing of staff through the end of 2019. Rall will contact the State Department for clarification on staffing decisions before the transition in 2020.

Commissions spoke with Estes concerning the issues on County Road 14A. Discussion followed concerning options for signing on the road. Discussion will continue while the Highway Department is at the meeting.

Xcel Energy representatives Warren Sakry, Sean Lawler, and Chris Chafy joined the meeting at 10:10 to update the Commission on the status of the Foxtrail Wind Tower Project. The project is close to being completed. The plan is to complete the project before freeze up. There is still tower work done on the south half and reclaim work on the north side has started. Sean introduced Chris Chafy, who will be the Operations Manager for the project, living in Ellendale. Hamar asked if it was possible to install a cell phone booster on a tower to assist with increasing the cell phone coverage in the area. Lawler stated he will look into that. Lawler thanked the Commission for their support for the project.

States Attorney Gary Neuharth and Social Services Director Rall joined the meeting at 10:25.

Rall returned to update the Commission on the information concerning the zone agreement. The agreement is effective January 1, 2020 but there will obviously be a transition period between now and the end of the year. The Commission is still in charge until January 1st and the current social services board will continue to meet through the end of the year. Neuharth reviewed the agreement and felt it is alright for Hokana to sign. Sand made a motion that while Dickey County agrees with state funding for Social Services and intends to meet the requirements of Senate Bill 2124, we recognize the difficulty and some inefficiencies in the process, but in order to stay in compliance with the state, the Commission will sign the zone agreement. Roberts seconded. Motion carried.

Risk Manager Cresta Miller joined the meeting at 10:30. Tax Director Don Flaherty, Highway Superintendent Jeff Hagen, and DES/911 Coordinator Charlie Russell joined the meeting at 10:50 Clerk of Court Andi Schimke joined the meeting at 11:10.

Simek made a motion to open propane bid hearing. Sand seconded. Motion carried. The bid was for 20,000 gallons more or less. The bids were received as below:

Farmers Union Oil \$0.90/gallon

Economy Propane \$1.05/gallon

AgTegra Cooperative \$1.089/gallon

Discussion followed concerning the wording on the bid received from Farmers Union, which the Commission feels needs to be clarified. Sand made a motion to close the bid hearing until with bids are reviewed. Simek seconded. Motion carried.

After clarification was received, Simek made a motion to accept the Farmers Union bid of \$.09 per gallon. Sand seconded. Motion carried.

Treasurer Cheryl Brokaw and Deputy Treasurer Wonada Lematta joined the meeting at 11:00 to review the properties that are delinquent in their taxes. The properties were reviewed and prices were discussed for the four properties.

Flaherty presented the changes that have occurred in the tax value since estimated tax statements were sent out. There will be an omitted tax hearing at the next meeting and then the value should be spent. Commission requested an update from Flaherty concerning the work completed by Vanguard. Flaherty stated that it went extremely well. Flaherty felt that we should have the results by the end of October or beginning the end of November.

Discussion on the state of County Road #14A with Hagen, Russell, and Estes. Signing that should be installed so that road. Russell will submit the project to ND FEMA to use their funds to fix that road, as it is not a Farm to Market road. Therefore, FEMA funds could be used. Russell will submit the information to FEMA for their approval. Work could be started as soon as we got approval.

Roberts made a motion to approve the budgets for 2020 budgets. Simek seconded. Roll call vote with Sand yes, Hokana yes, Roberts yes, Simek yes, and Hamar yes. Motion carried.

Hokana made a motion to adopt the social service redesign resolution. Roberts seconded. Motion carried. The resolution is on file at the Auditors office. Commission asked that Sheppard forward the resolution to the 5-County group, NDACo representatives, and our state legislators. Roberts seconded. Motion carried.

Sheppard presented the document received from North Dakota Department of Transportation concerning the maintenance of the county FAS roads. Roberts made a motion for the Chairman to sign. Sand seconded. Motion carried.

Neuharth returned to the meeting at 12:07 concerning releasing the executive session recording from August 20th to the Social Services employee. On the advice of the States Attorney, Sand motioned to release the executive session contents to the Social Services Director and the Child Protection Worker involved. Assistant States Attorney Kim Radermacher will be present during the review of the recording. Sheppard will retrieve the CD of the recording once it has been reviewed and the CD will be destroyed. Hokana seconded. Motion carried.

Hokana made a motion to adjourn at 12:20.

Commissioner Meeting October 15, 2019

Commissioner Joel Hamar called the meeting to order at 9:30. Present were Thor Sand, John Hokana, Dean Simek and Chairman Joel Hamar. Marke Roberts was unable to attend. The media was not present. The Pledge of Allegiance was recited.

Additions to the agenda

Security Buttons for Social Services

Sheriff Chris Estes joined the meeting at 9:40. Estes stated that the buildings taken back by the county for non-payment of taxes have all been locked up and that "No Trespassing" signs have been posted.

Hamar requested additional security buttons be installed out a Social Services. Estes stated they would get the buttons ordered.

Tax Director Don Flaherty joined the meeting at 10:15.

Simek made a motion to open the Omitted tax hearing. Sand seconded. Motion carried.

Flaherty presented three properties for the omitted tax hearing. The three properties were no longer eligible for farm residence exemptions. Notices were mailed to the land owners but there were none in attendance. Sand made a motion to accept the Tax Director Flaherty's recommendation to put the increases in value of the three properties on the tax rolls. Hokana seconded. Motion carried.

Hokana made a motion to close the omitted tax hearing. Simek seconded. Motion carried.

Commission reviewed the values on the properties for the tax sale in November. Simek made a motion to increase the minimum bid on parcel number 08083000. Sand seconded. Motion carried. All other parcels were left as discussed at the October 1st meeting.

Deputy Treasurer Wonada Lematta, DES/911 Coordinator Charlie Russell, and Highway Superintendent Jeff Hagen joined the meeting at 10:50.

Lematta presented the Quarterly Treasurers report for Third Quarter, 2019. Hokana made a motion for Chairman Hamar to sign. Sand seconded. Motion carried.

Lematta submitted a request to the Commission for funds to be returned to the ND Department of Trust Lands for unclaimed property. The check was issued to Machol & Johannes, LLC in the amount of \$20.00 and was cancelled June 19, 2018. Letters have been sent and no response has been received.

Simek made a motion to return the money to the ND Department of Trust Lands. Sand seconded. Motion carried.

Russell and Hagen spoke with the Commission on the work being done on the county line. Work had been done before the snow storm and all of that is now under water. Discussion followed concerning what could be done. Hagen will take to KLJ Engineer Chad Peterson concerning the site and what can be done.

Hagen requested hiring a part time truck driver for the winter months. With changes in staff, Hagen does not have enough employees with the requirements needed to use the equipment. Commission requested Sheppard to look at the budget to see if that is possible.

Health District Administrator Roxanne Holm joined the meeting to discuss the hiring of a Substance Abuse Prevention Coordinator. At the current time, this position would be fully funded through grant programs. After some discussion, Sand made a motion to accept the Public Health District Administrator Holm's request to add the Substance Abuse Prevention Coordinator to the salary schedule with Step 1 starting at \$40,924 and to offer the position to Abby Gibbs, starting at step 4. Simek seconded. Motion carried.

Hokana made a motion to approve the vouchers. Simek seconded. Motion carried.

Sand made a motion to approve the financials for September, 2019. Hokana seconded. Motion carried.

Hokana made a motion to approve the minutes from the October $\mathbf{1}^{\text{st}}$ meeting with changes. Sand seconded. Motion carried.

The 5 County meeting of County Commissioners is October 17^{th} at 5:00 in Hankinson. The agenda was reviewed.

Hokana made a motion to adjourn at 12:23.

Special Commissioner Meeting October 22, 2019

Commissioner Joel Hamar called the meeting to order at 10:00. Roll call taken with Thor Sand, John Hokana, Dean Simek, and Chairman Joel Hamar. Marke Roberts attended through teleconference. Also, in attendance were DES/911 Coordinator Charlie Russell, Highway Superintendent Jeff Hagen, Sheriff Chris Estes, and Dickey County Leader Editor Ken Smith.

The purpose of the meeting was to discuss the proposed flood declaration prepared by Russell. Russell informed the Commission on the increase in release of water from north of Jamestown once Jamestown and LaMoure have finished their preparations. Draining because of the unprecedented rainfalls from the summer and the winter snows from the has caused an increase in levels at Pipestem, which needs to be lowered before freeze up. The 102nd Street (State Line road) is closed at SD County Road 14, as the water is over the road already. Russell informed the Commission that Governor Burgum had declared a flood emergency yesterday. After some discussion, a few changes were made so that the declaration included the fact that issues include overland flooding and that the roads will continue worsen with the onset of harvest season.

The Commission went into recess at 10:35 so that clarifications could be typed into the resolution. The Commission reconvened at 10:40.

The declaration was read by Russell for their final review. Roberts made a motion that the Chairman and County Auditor sign the declaration. Hokana seconded. Motion carried.

OFFICE OF EMERGENCY MANAGEMENT DICKEY COUNTY NORTH DAKOTA October 22, 2019

FLOOD DECLARATION

WHEREAS: repeated snow and unprecedented rain events during the 2018/2019 have occurred in Dickey County causing an huge financial burden on our Townships, Cities and County roads departments leaving our county crippled by inundated road infrastructure; and,

WHEREAS: no relief in summer rain events, both in county and in the river drainages north of us, which has kept all rivers and streams systems in flood to near flood stage all summer- kept our roads severely damaged and has filled the storage dams north of us to overcapacity now requiring emergency releases; and,

WHEREAS: repeated road damage from unprecedented rain has left closed basin areas up to and/or on road surfaces, causing extreme roadbed damage, repeated overland flood damage, and depleted all highway gravel budgets, and

WHEREAS: limited routes have put undue pressure on current passable roads due to increase traffic and as harvest is upon us, increasing damage on our best roads, and

WHEREAS: our soil is saturated and our wetland areas, ponds and ditch systems are full and the James River has now covered a major north/south county road for the third time this year; and,

WHEREAS: immediate flood protection measures are needed to be placed to protect our citizens from James River flooding from historic releases from both dams north of us; and,

NOW THEREFORE BE IT RESOLVED, that The Dickey County Commission declares that a State of Emergency exists in Dickey County, our Townships and Cities requiring the activation and utilization of The Combined Dickey County Emergency Operations Plan, its procedures and attachments to monitor the ongoing situation, mitigate where possible; and to provide protection to the citizens of Dickey County during this upcoming event.

BE IT FURTHER RESOLVED, all local government agencies and departments are directed to provide protection to the citizens of Dickey County during this event and limit where possible the hardships and impact of said emergency.
