Commissioner Meeting November 5, 2020

Commissioner Marke Roberts called the meeting to order at 1:30. Present were Joel Hamar, John Hokana, Dean Simek and Chairman Marke Roberts. Thor Sand was present via electronic means. Resident Cindy Bagley and Clerk of Court Andi Schimke were also present. By electronic means, the following employees were also in attendance: States Attorney Kim Radermacher, Tax Director Don Flaherty, County Agent Administrative Assistant Shirlene Wagner, and Treasurer Wonada Lematta. The following contractors were in attendance via electronic means: Wenck Associates representative Todd Fryzek, Innes Construction representative Bryan Fosse, Kyburz-Carlson representatives Mike Keller and Jennifer Law, Manning Mechanical representative Zach Osbjornson, Mission Mechanical representatives Jody Slocum and Nick Wavra, Roers representative Keegan Ahern, Naseth Construction representative Scott Naseth, USDA representative Ranetta Starr. Scott's Electric representative Vance Wagner, and a contractor Casey S. The media was not present. The Pledge of Allegiance was recited.

Additions to the agenda

Dickey County #5

Hamar made a motion to approve the vouchers, with the addition of the distribution of FEMA funds received to several townships and Dickey County in the amount of \$48,566.56. Simek seconded. Motion carried.

Wenck Associates' Environmental Engineer Todd Fryzek joined the meeting via electronic means to request the approval of the Commission to allow the removal of soil that has a nitrogen level greater than 500 mg/kg. The soil is in 29-131-59 West in Bear Creek Township between 5th and 7th Street South, north of the railroad tracks, in Oakes, ND. It is estimated to be excavated to 2 to 3 feet on the east side, while the western area will be excavated to roughly 4 to 6 feet. The soil will be thin spread in a different location. Bear Creek Township has approved the project and Fryzek is asking for Dickey County's approval. After some discussion, Hokana made a motion to sign the Local Zoning Approval. Simek seconded. Motion carried.

Sand stated he had received a text from a resident, thanking the county for the work done on the roads. This required working extended hours, and resident felt they exceeded expectations to get the job done.

Sheppard presented a request to the ND Department of Transportation for reimbursement for expenses on the emergency grade raise on County Road #1. Hamar made a motion to sign the reimbursement. Simek seconded. Motion carried.

Hokana had received a call concerning the County Road 5 right of way. There are tall cattails and some old trees. Resident is asking they be removed, as they collect the snow. It is all in the county right of way. Resident is asking if a resident can remove them and get paid by the county. Simek stated he would talk with Highway Superintendent Hagen to see if the county could do the work.

Hamar made a motion to open the basement project bid hearing. Hokana seconded. Motion carried. Roberts turned the bid hearing over to Michael J Burns architect Kerry Peuser, who was in attendance through electronic means.

Upon the advice of the Assistant States Attorney Kim Radermacher, who was in attendance via electronic means, Hamar made a motion that missing one of the forms required by the USDA, which includes Certification Regarding Debarment, Compliance Statement, and Certification for Contracts, Grants, and Loans, would be considered a minor offense and contractor could submit the form, if awarded the contract. Simek seconded. Motion carried

The bids for the general construction, the mechanical, and the electrical portions of the project. Due to the complexity of the bids, the bid results are on file at the Auditor's Office. One bid did not have the copy of the contractor's license, which negates the bid. A bid for the mechanical portion was unable to be opened due to technical difficulties at the time of the bid opening.

Discussion followed concerning the bids and how they were quite a bit higher than projected. There were vast differences in the pricing, specifically the unit prices quoted.

Hokana made a motion to reject all bids. Hamar seconded. Peuser stated that one of the concerns of the contractors was to get the concrete out of the building. Peuser stated he would like to review the job, discuss with contractors who had bid, and come to the Commissioners with suggestions to rescoping the project. By rescoping the project, the project would have to be rebid. Motion carried. Peuser will review and report back to the Commissioners.

Hamar made a motion to close the bid hearing. Simek seconded. Motion carried.

Health District Nurse Amber Miller joined the meeting at 3:30 to update the Commission on Covid cases in Dickey County. During the county meeting on Wednesday, the request had been given that the county support the actions of the school, clinics, ambulances, and hospital. They feel that a culture of mask wearing needs to be supported. The city of Oakes and Ellendale are discussing the issue at their next council meetings as well. Commission discussed with Miller about the public information announcements put out by the Health District. A decision was made to include on the announcements including the support of the Commissioners.

Hokana made a motion to adjourn at 4:00.

Commissioner Meeting November 17, 2020

Commissioner Marke Roberts called the meeting to order at 9:05. Present were Thor Sand, Joel Hamar, Dean Simek, John Hokana, and Chairman Marke Roberts. Also, in attendance, was in-coming County Commissioner Jerry Walsh and resident Cindy Bagley. Employees Tax Director Don Flaherty and Clerk of Court Andi Schimke were also present via electronic means. The media was not present. The Pledge of Allegiance was recited.

In-coming County Commissioner Jerry Walsh introduced himself to the current Commissioners. Hokana made a motion to approve the minutes from October 19th, October 20th, and November 5th with corrections. Hamar seconded. Motion carried.

Simek made a motion to approve the vouchers. Sand seconded. Motion carried.

After a discussion concerning the balance in the Road fund, Sand made a motion to approve the Financials from October. Hamar seconded. Motion carried.

Residents Robert Gemar and Austin Smith joined the meeting at 9:32.

Treasurer Wonada Lematta joined the meeting at 9:32 to discuss the closing of the checking account at Starion and to transfer the money to the money market account at Starion. The account is a checking account that has not been used for several years and is not earning much interest. Lematta would like to move it into the saving account where it will earn a higher rate of interest, and there will not be the monthly fee that Dickey County is currently getting charged. On the recommendation of Treasurer Lematta, Sand made a motion to close the checking account and to put the money in the money market account at Starion Bank. Simek seconded. Motion carried.

Lematta informed the Commissioners concerning issues the Treasurer's office is having with receiving timely and accurate information from the Dickey County Water Board for the special assessments on the Dickey County Drain #1, Oakes Pilot Drain, and the Yorktown Maple Drain. Discussion following concerning the best way to resolve the issue. Sand made a motion to send a letter to the Water Board expressing the on-going concerns of the timeliness and accuracy of the assessments for the drains for correct assessment on property and requesting the issue to be resolved by the Water Board. Simek seconded. Motion carried. Chairman Roberts will sign the letter.

Architect Kerry Peuser joined the meeting at 9:48 via electronic means. Sheriff Chris Estes joined the meeting at 9:48.

Hamar made a motion to open up the County Land Sale. Sand seconded. Motion carried. Also, in attendance was Ellendale City Auditor Candy Middlestead. Auditor Sheppard read the purchase agreement conditions that were signed by all those in attendance to bid on the four parcels that were for sale. Delinquent property taxes have been checked by the Treasurer's office.

The legal description of parcel number 07857000 is Lot 14 Block 6 Original Plat, City of Ellendale with a minimum bid of \$2,425.95. No bids were received.

The legal description of parcel number 08300000 is Lot 11 Block 7 Ellendale Land Company, City of Ellendale with a minimum bid of \$9,333.05. No bids were received.

The legal description of parcel number 10060000 is Lot 22 Block 9 Original Plat, City of Oakes with a minimum bid of \$2,409.79. No bids were received.

The legal description of parcel number 10321000 is Lot 12 Block 8 Washburn's Addition, City of Oakes with a minimum bid of \$8,082.06. Sheppard accepted a bid in the amount of \$8,802.06 from Cindy Bagley. No other bids were received. The minimum bid of \$8,082.06 was accepted. The current owner will need to be evicted from the residence by Dickey County.

The legal description of parcel number 11435000 is Lot 7 Block 17 Second Addition, City of Monango with a minimum bid of \$253.62. Sheppard accepted a bid in the amount of \$253.62 from Austin Smith. No other bids were received. The minimum bid of \$253.62 was accepted.

The legal description of parcel number 03863100 is N 27 Rods of E 12 Rods of Ne1/4 of NW1/4 of Section 7-131-61 with a minimum bid of \$139.67. Sheppard accepted a bid in the amount of \$139.67. No other bids were received. The minimum bid of \$139.67 was accepted.

The legal description of parcel number 0543001 is part of the NW1/4 of 5-131-63 with a minimum bid of \$77.56. No bids were received.

The legal description of parcel number 06375500 is part of the SW1/4 west of Highway 56 except for the US Fish and Wildlife land in section 3-131-66 with a minimum bid of \$2,086.08. No bids were received.

Sand made a motion to close the tax sale. Simek seconded. Motion carried.

Sand made a motion to abate the taxes on parcels 07857000 and 08300000 and deed the parcel back to the city of Ellendale, abate the taxes on parcel 10060000 and deed the parcel back to the city of Oakes, and abate the taxes on parcels 0543001 and 06375500. Hamar seconded. Motion carried.

Discussion followed concerning parcel number 06375500. Commission would like to have KLJ look at the parcel to see if the county could use the land for wetland mitigation. Sheppard will forward the legal description to Engineer Tykwinski.

South Country Human Services Zone Director Michelle Massett joined the meeting via electronic means at 10:39 to discuss the policy review required by North Dakota Century Code to be completed by December 1st. Hokana made a motion to accept the policies presented by Massett. Simek seconded. Motion carried. Discussion followed concerning the definition of indirect costs that needs to be reviewed by the state of North Dakota.

A request was made to reopen the tax sale to accept a bid on parcel 06375500, which was denied.

Resident Jim Grueneich joined the meeting at 10:40. Grueneich presented to the Commission petitions signed by 17 residents of the Pheasant Lake area on the development of a recreation district at Pheasant Lake. Discussion followed concerning the requirements of the development of such a district. Because the item was not on the agenda due to an error by the Auditor's office, a decision was made to put it on the agenda for the December 1st meeting and it will be discussed at that time.

Highway Superintendent Jeff Hagen and KLJ Engineer Bryan Tykwinski joined the meeting at 10:46.

Simek presented a request he had received from Don G Zimbelman concerning permission to install three culverts in the berm on County Road 3 in SW1/4 24-131–62. Zimbelman is asking for permission with the cost at his expense. Simek made a motion to allow the culverts to be installed, as shown on the map, at the expense of the land owner. Hokana seconded. Motion carried. Simek will contact Zimbelman. Discussion followed that the motion could be altered if Zimbelman would decide that removal of the berm in those areas would work better, that could be done.

Tykwinski presented the revised County Federal Aid Program sheet for 2021, which needs to be approved by the Commission and signed. The projects are listed as discussed, but can always be changed based on the need. Sand made a motion to sign the program sheet. Simek seconded. Motion carried.

Sheppard presented the Preliminary Engineering Services Agreement for the grade raise on County Road 1, 7 miles north and 0.5 miles west of Oakes. Simek made a motion to sign the agreement. Hamar seconded. Motion carried.

Architect Kerry Peuser and USDA representative Ranetta Starr rejoined the meeting at 11:36 to discuss the basement. Discussion followed concerning the reasoning for the increase, over the original projected amount of the project. Due to the location of the vendors that bid, the cost of travel, hotel, and food was increasing the cost by approximately \$60,000. The major issue in the basement is the wicking in the walls and the basement slab. Other options were discussed. Discussion followed concerning rebidding the project with the same scope or changing the scope of the project. Additional funding would need to be located, as the grant and loan from the USDA will not cover the cost of the project as bid. A decision was made to rebid the project as is and to add an option to not remodel the sheriff's office but to fix the structure. Discussion followed concerning the loss of a \$100,000 grant through South Central Dakota Regional Council because of a delay at the state level.

The Executive Order by Governor Burgum was discussed. Sand presented the resolution shown below.

Dickey County recognizes and is concerned with:

- the increase in deaths.
- the mental and spiritual wellbeing of those in quarantine.
- the increased burden on emergency personnel and health care workers.
- the economic impact of shutdowns and mandates.
- the increased division being created and enhanced by attempting to force compliance with state health guidelines.
- the emotional and psychological impact of death, fear, disease, masks, and uncertainty.
- the increase in loneliness and depression.
- the damage being done to families not able to visit loved ones during the end of life as well as day to day.
- the relationship between public health, law enforcement, and the public.
- the arbitrary nature of mandates being put in place.
- the arbitrary nature of school and sporting events guidelines.
- the impact of shutdowns and cancellations.
- the inability to access reliable statistics for total deaths (showing the increase over a normal death rate) as well as sound scientific studies.
- the ability of many businesses to continue to survive.
- the unforeseen and unintended effects of the virus and response to it.

the lack of respect for North Dakota citizens and businesses intelligence and ability to weigh the risks and make personally responsible decisions for themselves.

Let it be known that today, the Dickey County Commission stands opposed to mandating hours of business operation, forced reduction in business capacity, required cancellation of school activities, and requiring the use of face coverings. Dickey County does encourage citizens and businesses to do what they can to help reduce and ease the impacts of Covid 19 and the response to it. This may or may not, include reducing hours of business operation, limiting capacity, canceling school and other events, and the use of face coverings. Dickey County realizes that this may look different for each business and individual. Citizens, businesses and local governments need to be in control of their own health care and have the freedom to commence business and life as they see fit.

Sand made a motion to approve the above stated resolution. Roberts seconded. Discussion followed. Roll call vote with Hokana no; Simek no; Sand yes; Hamar yes; Roberts yes. Motion carried. Commissioner Sand requested that the above resolution be forwarded to Governor Burgum's office.

Discussion followed how the staff should handle the masks in their office. Commission are displeased with the law but it is in place and each office should do as they see fit.

Hokana made a motion to adjourn at 1:48.
