Commissioner Meeting January 7, 2020

Commissioner Joel Hamar called the meeting to order at 9:00. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek and Chairman Joel Hamar. The media was not present. The Pledge of Allegiance was recited.

Additions to the agenda

Pheasant Lake and Elm Township

E-mail from National Weather Service

Sand made a motion to approve the minutes from December 17th and 27th with corrections. Simek seconded. Motion carried.

Hamar reviewed the e-mail received from John Paul Martin, from the National Weather Service, concerning the assistance of Charlie Russell during the last winter storm. The letter is a commendation for Russell's work and the assistance Russell gave to them.

Phone calls have been received from Elm Township residents concerning the county's plan to not contract to clean the road out at Pheasant Lake. The Commission again stated that it is not economical for the county and our equipment is too big for the area. The road was opened after the last storm, which concluded the contract with Elm Township for 2019.

With no other business from 2019, Hokana moved to adjourn the final 2019 business meeting at 9:17.

Auditor Sheppard called the 2020 Reorganization Meeting to order at 9:18 and asked for nominations for Commissioner Chairman. Simek nominated Mark Roberts. Sand seconded. Hamar made a motion to cease nominations and to cast a unanimous ballot for Marke Roberts. Simek seconded. Motion carried.

Roberts thanked Hamar for a job well done the last two years as Chairperson.

Roberts asked for a motion for Vice Chairman. Hamar nominated John Hokana. Simek seconded. Sand made a motion to cease nominations and to cast a unanimous ballot for John Hokana. Hamar seconded. Motion carried.

The current county portfolios were discussed. Hokana made a motion to keep the portfolios the same. Hamar seconded. Motion carried.

The list of county board appointments that need to be appointed were reviewed. A position for the Water Board, Weed Board, and the Park Board are open. Sheppard will send an advertisement to the paper requesting applicants as well as a letter out to the board members that expired in 2019. Appointments will be reviewed at the next Commissioner meeting.

Hokana made a motion to dissolve the Social Services Board, due to the change in legislation and the formation of the South Country Human Services Zone Board. Simek seconded. Motion carried.

Sand made a motion to dissolve the Detailed Soils Board, as it is already in place and is established. Hamar seconded. Motion carried.

Simek made a motion to approve the vouchers. Hokana seconded. Motion carried.

Roberts presented a Gaming Site Authorization form from the Hole in One Foundation. Hokana made a motion to approve the application and to waive the fee. Simek seconded. Motion carried.

Health District Administrator Roxanne Holm joined the meeting at 10:15 to discuss the use of the automobiles originally used by Social Services by a Health District employee who is attending training in Bismarck next week. Sand made a motion to allow the use of the vehicle for this employee. Based on the expired policy of Social Services Hamar seconded. Motion carried. Sheppard and Holm will work with information from Social Services to develop a policy and to research a calendar that could be used by all interested employees for scheduling of the automobiles.

Environmental Services employees Scott Peterson and Dan Blondo joined the meeting at 10:29 to discuss with the Commissioners concerning the new lawn mower budgeted in 2020 for the Courthouse. Peterson will check with the vendor to verify price, as the quote is 6 months old, and a possible delivery timeframe.

Highway Superintendent Jeff Hagen and Deputy Recorder Kelly Schmidt joined the meeting at 10:42.

Sheppard presented three Quit Claim deeds for property sold or deeded to the City at the tax sale in November. Hamar made a motion to sign the deeds on parcel numbers #11428000 in Monango, #08462000 in Ellendale, and #11021000 in Forbes. Simek seconded. Motion carried. Schmidt notarized the signatures on the deeds.

The meeting went into recess and reconvened at 10:51. Sheriff Chris Estes joined the meeting.

Hagen informed the Commission that the Oshkosh truck and snowblower should be delivered Thursday, depending on the weather. Hagen stated he had received calls from a few farmers that had assisted in removing snow last year, offering to assist again. Hagen approved them to assist with blowing snow on then Glover road and on County Road 3C after this last storm.

Estes updated the Commission on the use of the new side-by-side with rescuing of individuals in the last storm. The individuals rescued were people living outside of the state.

Sand made a motion to approve the PAT software agreement. Simek seconded. Motion carried. Simek made a motion to sign the yearly agreement with South Central Dakota Regional Council. Hokana seconded. Motion carried. Sheppard will ask for more information and the guidelines of what services they offer so the county and cities in the county can use these resources provided by this agreement.

Hamar made a motion to sign the software license agreement with Vanguard Appraisals. Simek seconded. Motion carried.

Sheppard requested a change in venue for the February 4th Commissioner meeting, due to the Commissioner Room being used at that time. A decision was made to request the use of the meeting room at Oakes City Hall. Sheppard will reserve the room.

Sand spoke of the need for residents to express their opinions to the State of North Dakota on the use of Legacy fund money. Discussion followed concerning the installation of natural gas in other areas and that would be an excellent use of those funds.

Hokana made a motion to adjourn at 11:51.

Commissioner Meeting January 21, 2020

Commissioner Marke Roberts called the meeting to order at 9:45. Present were Thor Sand, John Hokana, Joel Hamar, Dean Simek and Chairman Marke Roberts. The media was not present. The Pledge of Allegiance was recited.

Additions to the agenda

Report from South Country Human Services Zone (new Social Service zone) Hokana made a motion to approve the minutes from January 7th with corrections. Simek seconded. Motion carried.

Simek made a motion to approve the vouchers. Sand seconded. Motion carried.

Hamar made a motion to approve the financials from December, 2019. Hokana seconded. Motion carried.

Sheriff Chris Estes joined the meeting at 9:50 to discuss vacation that was not used before the end of the year by his Administrative Assistant. Due to staffing and the timing required for filing of reports, Sand made a motion to approve the extension of the deadline to use vacation from 2019 to March 31, 2020. Any hours not used by March 31st will be forfeited. Hamar seconded. Motion carried.

South Central Dakota Regional Council staff Traci Redlin and Dickey County resident Eric Larsen joined the meeting at 10:05.

Redlin presented the revised Hazard Mitigation plan for Dickey County for the Commissioners approval. Redlin discussed the meetings held throughout the county and the cooperation of all the different agencies. Once this is approved, the county will be able to continue to get assistance through FEMA during disasters. This plan needs to be updated every 5 years. This is an update from the original plan. Hokana motioned to approve the plan. Sand seconded. Motion carried. Redlin stated Dickey County should receive grant money to cover the cost of developing the plan.

Job Development Authority Secretary Don Flaherty joined the meeting at 10:30 to discuss board appointments for JDA. Butch Middlestead has resigned and Bridget Henning was appointed by the Ellendale JDA to replace Middlestead. Resident Judith Reiser who is a representative for Townships has resigned and Cory Reiser has stepped in to fill that term. Sand made a motion to accept the recommendations from the organizations and appoint Henning and Cory Reiser to the JDA Board. Hamar seconded. Motion carried

Hamar made a motion to appoint Bob Schmidt to the Park Board for another term. Simek seconded. Motion carried.

Resident Justin Gemar, Health District Administrator Roxanne Holm, Administrative Assistant Kerry Waldo joined the meeting at 10:40.

At the current time, Sheppard has not received any interest on the Weed Board position. Commission will wait to make that appointment.

Sheppard updated the Commission on the Board position for the Water Board. Four residents have shown interest in the position. Resident Eric Larsen stated he would strongly encourage the Commission to appoint Justin Gemar, as Gemar lives close to the drain issues in the Fullerton area. After discussion on the different applicants, Simek made a motion to appoint Gemar to the Water Board. Hokana seconded. Discussion followed that the decision would not be due to ill management of the Water Board members, but having more Board members where the issues currently are. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, and Roberts yes. Motion carried. Sheppard will send a letter to Kevin Strobel and the Water Board to thank Strobel for his many years of service on the Water Board.

DES/911 Coordinator Charlie Russell, Highway Superintendent Jeff Hagen and KLJ Engineer Brian Tykwinski joined the meeting at 10:52.

Holm and Waldo presented the new automobile use policy for the Commissioners to review. After some discussion and a few changes were made, Hokana made a motion to accept the new policy. Sand seconded. Motion carried.

Treasurer Wonada Lematta joined at 10:55. Lematta shared a report with the Commission on the state of taxes received currently compared to last year.

Lematta presented the list of Depositories to be approved for 2020. Included on the list is BankNorth, Starion Financial of Oakes and Ellendale, First Community Credit Union, Dakota Plains Credit Union, and Choice Financial of Ellendale. Hamar made a motion to accept the list of Depositories. Simek seconded. Motion carried.

Simek made a motion to remove retired Treasurer Cheryl Brokaw and to add Deputy Treasurer Lori Wald to the signature card at Starion Bank, on Lematta' s request. Sand seconded. Motion carried

Lematta presented the Treasurers Quarterly report and Pledge Report. Sand made a motion to approve the report and have Roberts sign. Hamar seconded. Motion carried.

Tykwinski gave an update to the Commission on the road project on County Road 14 and County Road 8. The bid date has been moved another month, currently set for April. The Corp is asking for some possible options other than the original proposal. The ND DOT is in full support of the current plan. KLJ will keep the Commission up to date on the project.

Hagen updated the Commission on the current status of the roads in the county. Hagen updated the Commission on the new truck and snowblower purchased the end of December. The equipment will require two employees when operating the truck and snowblower.

Sheppard presented the Bridge Inspection and Load Rating Services agreement received form the ND DOT for 2020. States Attorney Gary Neuharth has reviewed and approved the contract. Simek made a motion to sign the contract. Sand seconded. Motion carried.

Russell updated the Commission on the status of the FEMA projects. Discussion followed about the need for storm shelters in the county.

Hokana updated the Commission on meetings for the South Country Human Services Zone Board. The Zone Board will be meeting In Ellendale in February.

Discussion followed concerning the lighting in the Courthouse parking lot that will be updated by Montana Dakota Utility. There will be a very slight increase in the utility bill.

Sheppard presented the revised contract for the purchase of a new John Deere mower for the Courthouse. Sand made a motion to approve the contract. Hamar seconded. Motion carried.

Hokana made a motion to adjourn the meeting at 12:30.
