Commissioner Meeting September 7, 2021

Commissioner Marke Roberts called the meeting to order at 9:00. Present were John Hokana, Joel Hamar, Dean Simek, Jerry Walsh and Chairman Marke Roberts. The media was not present. The Pledge of Allegiance was recited. Also in attendance via electronic means were Deputy Auditor Stormy Bertsch, Clerk of Court Andi Schimke, and Administrative Assistant Shirlene Wagner.

Hamar made a motion to approve the August 17th minutes with corrections. Walsh seconded. Motion carried.

Hokana made a motion to approve the vouchers with the addition of \$1,060 to the Office of the Attorney General for the 24/7 program and \$26,500 payment to Growing Small Towns for a loan through Job Development Authority, and the removal of \$85 charge from NDSU and non-payment to the city of Ellendale until Hamar speaks with the city Auditor. Hamar seconded. Motion carried.

Sheriff Chris Estes joined the meeting at 9:24. Commission requested assistance with the removal of personal property stored on county park property at Pheasant Lake. As the letter stated that was sent to the residents at Pheasant Lake, the property was to be removed by September 1st. Estes will talk the residents and if the situation is not rectified, action will be taken to remove the items at the cost of the landowner.

County Agent Breana Kiser and Family and Community Wellness /4-H and Youth Development Agent Danielle Dinger joined the meeting at 9:34 to update the Commission on current activities in the county.

States Attorney Kim Radermacher joined the meeting at 9:45.

Walsh updated the Commission on the lower-level construction project. Currently the windows are being worked on and the tile is being placed. The tiles with the logo on them are here but have not been placed at this time. The next construction meeting is set for September 14th.

Walsh had approved two proposals from Dickey Rural Network for the access control system for the Sheriff's office in the amount of \$5,507.31 and the upgrade of the security cameras in the amount of \$6,817.37. These are a part of the lower-level project, but have been approved for funding through a Homeland Security grant. Hokana made a motion to approve the two proposals from Dickey Rural Network. Hamar seconded. Motion carried.

Discussion followed concerning the air conditioning unit from the west side of the building. The unit was working before the demolition of the basement and is no longer working. After the Zoom meeting August 31st, Mission Mechanical will be betting back to the Commissioners about the situation and how to fix the issue.

Sheppard presented a Document G701 for approval by the Commission, which is a consolidated list of change orders since the original bids from JDH Construction and from Mission Mechanical. The original change orders have been signed earlier. Simek made a motion to sign the documents. Walsh seconded. Motion carried.

Sheppard presented a special liquor transfer license for the Ludden Tavern for an event on September 4, 2021 at the Guelph Community Center. Sheppard stated the application was received late because of the application not received in the mail. Estes and the township have approved the application. Roberts had signed the permit in advance. Hokana made a motion to approve the application. Simek seconded. Motion carried.

Sheppard presented a special liquor transfer license for the Angry Beaver for an event on January 22, 2022 at the Guelph Community Center. Estes and the township have approved the application. Hamar made a motion to approve the application. Walsh seconded. Motion carried.

South Central Dakota Regional Council (SCDRC) representative Jennifer Schultes joined the meeting at 10:20. Schultes updated the Commission on the different programs that SCDRC offers. Discussion followed about the need to make the public aware of the different programs.

DES/911 Coordinator Charlie Russell, Highway Superintendent Jeff Hagen, KLJ Engineer Bryan Tykwinski, and Sargent County resident Brenda Schreiner joined the meeting at 10:45.

The meeting went into recess at 10:50 and returned at 11:02.

Walsh introduced Schreiner and updated the Commission on the conversation they had concerning a railroad crossing on the east side of Oakes on 111th Avenue. It is a blind intersection on a township road. Schreiner stated that there was a near miss at the intersection. Estes stated that the trees have been trimmed back to help with the blind intersection. Estes has spoken with the landowner and the railroad concerning the issue. James Valley Grain is looking into what can be done. An update will be given at the next Commissioner meeting.

Tykwinski updated the Commissioners on the Highway 1 grade raise project. The end date of the project is September 17th and they should be completed by then.

Tykwinski stated that Braun Intertech has completed their testing on County Road 8. It will take a couple of weeks before the results are received. Once that is received, KLJ can finalize the pavement design. Tykwinski stated that County Road 3 east of Oakes would be a good project to apply for, using the Special Road Fund. This project has been applied for using this fund, but has been denied but Tykwinski will submit the project again.

Walsh updated the Commission that a representative from TeamLab is willing to come to the next Commissioner meeting to make a presentation on their products. Sheppard will place it on the agenda for September 21st.

Hagen presented an agreement with Bear Creek for the maintenance of 85th Street from Highway 1 four miles east to the Sargent County line. The road is a township road, but the County had agreed to assist with the maintenance of the road as it led to the grain elevator in Crete. Discussion followed concerning the continuation or cancellation of the agreement, as there no longer is a grain elevator. Walsh made a motion to return the contract unsigned and to apply gravel and grading to the road to bring it into good status. Hokana seconded. Discussion followed that the gravel and blading of the four miles would be at a shared cost of the county and the township. Hagen will inspect the road to verify what needs to be done to bring the road to good status. Hagen will contact Bear Creek Township. Motion carried.

Hagen informed the Commission that the State Health Department came and completed an audit of the Highway Shop. The largest issue was the need for the sand/salt pile to be in a building. Health Department felt that the location of the pile was appropriate but it needed to be in a building. Discussion followed concerning a building for the pile, that may be able to be shared with the city of Ellendale.

Simek made a motion to advertise for up to 3 new motor graders with a bid opening for October 7^{th} . Hokana seconded. Motion carried.

Estes informed the Commission of the difficulty of locating jail space. The County will need to expand its area to allow additional jail locations, as the current area is not large enough.

Sheppard informed the Commission that the 5-County meeting is set for September 16th at 5:00 pm.

Hokana made a motion to adjourn at 11:55.

Commission Meeting

September 21, 2021

Commissioner Marke Roberts called the meeting to order at 9:35 am. Present were John Hokana, Joel Hamar, Dean Simek, Jerry Walsh and Chairman Marke Roberts. The media was not present. The Pledge of Allegiance was recited.

Hamar made a motion to approve the minutes from September 7th with changes. Simek seconded. Motion carried.

Hokana made a motion to approve the vouchers. Walsh seconded. Motion carried. Discussion followed concerning the use of vendors outside of Dickey County. Sheppard will send a reminder to all staff to make purchases through vendors in Dickey County, when possible. Sheppard will include a reminder that the county credit card should be used only for emergency purposes, per the County credit card policy. Discussion followed concerning accepting of bids for vendors outside of Dickey County. As stated in Century Code, Dickey County should accept the "lowest responsible bidder."

Hamar made a motion to approve the August 2021 financials. Simek seconded. Motion carried. Walsh updated the Commission on the lower-level project. The tile in the rotunda area is completed, but is currently covered for protection. The completion date of Sept 30th should be achieved. Sheppard presented two form G701s for signature, which is a correction from earlier forms already filed. Simek made the motion to sign the G701 forms. Hokana seconded. Motion carried.

Sheppard presented three sealed bids received for the sale of the 2013 Ford Explorer with 146,461 miles. The three bids received were from Jamie Nelson for \$4,500, Bayridge Motors Inc for \$3,589, and Ringwood Motors for \$2,688. Hokana made a motion to accept the high bid from Jamie Nelson. Hamar seconded. Motion carried.

Hamar updated the Commission on the 5-County meeting held in Grand Rapids Thursday, September 16th. NDACo representatives Aaron Birst and Linda Svihovec presented to those in attendance guidelines from the Interim Ruling on the American Rescue Plan Act. 42 of the 53 counties have made their request for the funds, including Dickey County. Redistricting of Commissioner districts and legislative studies that could affect counties were also discussed. Sargent County will take over as the new board for 2022. The next meeting will be in December.

TeamLab representatives Steve Neppl and Gary Syverson joined the meeting at 10:49. KLJ engineer Bryan Tykwinski and Highway Superintendent Jeff Hagen joined at 10:52.

Hamar updated the Commission on the status of personal items stored on County Park property out at Pheasant Lake. A wood pile was removed by the Highway employees and will be charged to the landowner. A semi and trailer have been moved so that it is no longer on Park property.

Hamar updated the Commission on the bill received from the City of Ellendale due to the water leak on 3rd Avenue North, which affected the Highway Shop. The original bill was in the amount of \$12,180. Hamar attended the City Council meeting to discuss the invoice. The City Council agreed to only charge Dickey County for the installation costs, which were \$5,306. The city will pay the difference. Hamar thanked the city for being receptive to reconsidering the billing of the county.

Sheppard presented a temporary liquor license transfer request from The Last Shot in Oakes for October 9th at the Guelph Community Center. Sheriff Estes has been contacted by The Last Shot and has approved the security for the event. Sheppard has forwarded the paperwork to Hudson Township, but has not received the approval back. Hokana made a motion to approve the temporary liquor license to The Last Shot, pending on approval of the township. Simek seconded. Motion carried.

Neppl and Syverson presented information on their product, Base 1, which is a road-based stabilizer product. Detail was given on a project completed in McKenzie County. Commission asked for the locations where the product was used and names to contacts at those locations.

Tykwinski stated that the grade raise on County Road #1 has been completed. The signs should be taken down. Tykwinski stated that there should be cost savings on the project, as less borrow material was used to complete the project. Tykwinski stated that the bridge northeast of Monango slated for repairs in 2022 is a historical structure. Extra steps will need to be taken, because of this finding.

Tykwinski reminded the Commission of the NDACo conference on October 4th and 5th. Dickey County's meeting with the NDDOT is Tuesday, October 5th at 10:15 am. Walsh, Hagen, and Sheppard will be in attendance for that meeting.

Walsh made a motion to recess the meeting at 11:47, to return at 1:00 pm for the 2022 Budget hearing.

The Commission returned at 1:05 pm for the 2022 Budget hearing. All Commissioners were in attendance and no one from the public was in attendance.

Commission reviewed the budget as presented. Discussion followed concerning all the changes that were able to occur in 2021 and 2022 with no increase in the number of mills charged to each parcel. Examples would be the remodel of the lower level of the courthouse, new motor graders, a new computer server, new phone system, repair of County Road 8 and the bridge northeast of Monango, and a new truck for the highway department.

Hamar made a motion to approve the Dickey County budget for 2022 as presented. Simek seconded. Roll call vote with Hokana yes; Simek yes; Walsh yes; Hamar yes; Roberts yes. Motion carried.

Walsh made a motion to close the 2022 Budget hearing. Hamar seconded. Motion carried. Hokana made a motion to adjourn 1:40.
