Commissioner Meeting December 6, 2022

Commissioner John Hokana called the meeting to order at 8:30 am. Also present were Jerry Walsh, Joel Hamar, Dean Simek, and Marke Roberts. Auditor Sheppard and new Commissioner elects Kacey Holm and Brandon Carlson were also present. The media was not present. The Pledge of Allegiance was recited.

Walsh made a motion to approve the draft of the November 15th minutes with corrections. Hamar seconded. Motion carried

An addition to the old business section was the mower ordered for the county park.

Archery Team Leaders Travis Anliker and Jim Glynn joined the meeting at 8:50, as well as Clerk of Court Andi Schimke who joined via electronic means.

Hamar requested information from Anliker concerning the cost of materials used in the upgrade of the Fair building used for archery. Anliker had receipts for \$56,500, showing proof of what the cost was. Hamar suggests that the Fair Board reimburse the Archery Club for those receipts. Anliker noted that there is a significant amount of volunteer labor that is not included in that number. Hamar made a motion to have the Fair Board reimburse the archery for the repairs they do to the building, which would be the costs they can prove. Anliker questioned who is going to take care of the building after this payment is made. Simek seconded. Holm reiterated that the Fair Board is not against what the youth are doing, but became concerned when discussions started about using the building for other residents to learn or practice archery. Walsh feels it is a Fair Board issue to figure out, not so much the County Commission. The question of insurance was brought up, as to whom should be paying the insurance. Discussion followed concerning the formation of a club, that would have that insurance coverage. Starion Insurance representative Dustin Meyer should be invited to the next meeting to discuss the issue of the additional coverage. Holm stated that the Fair Board will make a proposal of what they see needs to happen. Hamar withdrew his motion. Simek withdrew his second.

States Attorney Kim Radermacher joined the meeting via electronic means at 9:24.

Tad Lake was discussed in a prior meeting, concerning the placement of a boat landing there for the publics use. Carlson stated he has been talking with Game and Fish concerning this. ND Game and Fish has stated to Carlson they would be very happy to make a landing at Tad Lake. Discussion followed concerning CRP land along the shore line and the possibility of that land being for sale. Carlson will look into further.

Deputy Recorder Kelly Schmidt joined the meeting via electronic means at 9:30.

Hamar informed the Commission that he had received a call from RDO Equipment on the mower purchased for the Park Board. It has been delivered to Aberdeen. Hamar suggested to the Commission that the Park mower be used at the Courthouse to speed up the mowing process. The Commission could opt to see the one used at the courthouse instead. Discussion followed concerning trying the Park Board mower, before trying to sell it.

Remaining Commissioners also thanked them for their years of service.

Walsh made a motion to adjourn the old business portion of the meeting at 9:55.

The meeting reconvened at 9:55. Holm and Carlson took the Oaths of Office as County Commission for District 1 and District 3, respectively.

Hokana congratulated Holm and Carlson on their election to the Board of County Commission. Hokana reminded them that it is a group of five and their job is to serve the public.

Roberts made a motion to approve the vouchers presented. Walsh seconded. Roll call vote with Walsh yes; Carlson yes; Holm yes; Roberts yes; Hokana yes. Motion carried.

Walsh presented to the Commission a report given at the Job Development Authority (JDA) meeting November 29th by Growing Small Towns creator Rebecca Undem.

Additional meetings for the week of December 5th were discussed. The Dickey County Township Officers Association meeting is Wednesday at noon at CBS'. A meeting with the Supreme Court Chief Justice Jensen is scheduled for 1:30 pm in the Dickey County Courthouse, and followed by the 5-County Commissioner Association meeting in Edgeley.

Schimke updated the Commission on the purpose of the meeting with Chief Justice Jensen, which is to discuss the upcoming legislation being introduced in the next legislative session to convert all Clerk of Court offices to state employees. Schimke discussed the tasks that are completed in the Clerk of Courts office that will need to be moved to another office in the courthouse, including passports,

marriage licenses, veteran's discharge papers, risk manager duties, testing the door system Ipad's, and the lock box for the key system. Discussion continued to update Holm and Carlson on the resolution passed at the November 15th meeting stating that the Dickey County Commissioners oppose the legislation.

Meeting went into recess from 10:30 am to 11:00 am for US Army Corps of Engineers web meeting on the National Inventory of Dams website and online tools for risk assessment and decision making.

Sheriff Chris Estes, Highway Superintendent Jeff Hagen, and KLJ Engineer Bryan Tykwinski joined at the meeting at 10:52.

Estes updated the Commission on the Active Shooter training that had occurred at the Ellendale Public School. Estes stated that the Ellendale Police Department had informed Estes that it was a teacher training and they did not need to attend. The next training is slated for December 14th for training at the school in the morning. School Board Member Cresta Miller joined the meeting and stated she would speak with the Board about the issue and will communicate with Estes after their Board meeting.

Risk Manager Cresta Miller stated that she had completed her office inspections for risk management issues for 2022. There are a couple of changes that Miller is currently working on. Discussion included a possible increase in the amount allowed for reimbursement of safety equipment, such is currently \$300 per year.

Hagen welcomed Holm and Carlson to the Commission Board. Hagen stated that the truck ordered in 2021 will be built starting January 24.

Hagen informed the Commission that bridge number 11-128-10.0, located one mile north of County Road 3 on County Road 8. The load limit has been found to have insufficient load carrying capacity. Signage will need to be installed by January 4, 2023 with the weight limit of 29 gross tons. Hagen stated that a request has been sent to DOT to get the bridge report to see what issues there are.

Roberts requested the property list of what ditches were mowed, along with the pictures. Discussion continued about the process of mowing ditches and when the landowner is charged. Hagen stated there are times where they clip 50 feet and don't bill for the short distance. Roberts stated he wants a list of all places that were mowed. Guidelines were discussed.

Complaints of no sanding have been received. Hagen discussed the issues with sanding and the low temperatures. Discussion followed concerning the possibility of piling material on the east side of the county. Hagen will check with the city of Ellendale on the agreement to use their building for sand/salt storage. Hagen will also speak with the city of Oakes about stock piling in Oakes.

Tykwinski discussed with Commission about bridge funding, which would be at 100% funding. If accepted, it would not occur until 2024 or 2025 for construction. Discussion followed concerning looking for other options for funding.

Treasurer Lematta spoke with Commission about funds that are not collected interest, but could be moved into a CD to receive additional interest. Walsh made a motion to move funds to a financial institution and purchase a CD to receive additional interest on these funds. Roberts seconded. Roll call with Holm yes; Carlson yes; Walsh yes; Hokana yes; Roberts yes. Motion carried.

Carlson questioned if Dickey County should declare an emergency disaster due to the ice storm. Russell felt there was not efficient damage to do so.

The meeting went into recess 12:20 for lunch and reconvened at 1:30.

The following people joined the meeting at 1:30: Gary Hoffman, Elaine Hoffman, NaTanya Olson, Darrell Schrum, Mike Klipfel, James Tiegs, Michelle Mueller, John Lynde, Lorena Lynde, and Myron Myers. Jodi Waltman and Dom Davis joined via electronic means. Summit Carbon Solutions representatives Charlie Adams and Jeff Skaare were also in attendance. States Attorney Kim Radermacher is also in attendance. Commissioner Hokana is no longer in attendance.

Olson asked what the Commission have done concerning the CO2 pipeline. Walsh pointed out the Commission made a resolution opposing the use of eminent domain on this project. Radermacher stated that the zoning committee has not met for several years and that some townships have zoning regulations. Radermacher stated that her legal opinion is that it is too late to change or add any zoning specific to this project.

Olson requested that the Commission change their resolution to an ordinance, require the pipe to be buried a minimum of 8 feet deep, and no pipeline within a mile of an occupied or unoccupied houses. Olson feels Dickey County should require SCS to pay a million dollars a mile to Dickey County to place in a fund to cover costs in the future, as an example for the disposal of the pipeline when no longer in use. Walsh stated that the Commission would not make a motion to change the resolution to an ordinance without the full Commission in attendance.

Radermacher stated that legally the Commission cannot stop eminent domain in this case. County would have to put a zone ordinance in place. Radermacher stated legally they have no authority to place a moratorium as we don't have any zoning in place before the start of the pipeline.

Klipfel stated that base on the health risk involved in the pipeline, the county could place a moratorium on the project to give the county an opportunity to look into their options.

Gary Hoffman feels it would be in the best interest of Dickey County to take a stand with other counties in the fight to keep the pipeline out of the county. Hoffman questioned if the surveyors are licensed to survey in North Dakota. Skaare stated that they are licensed in North Dakota. The meeting minutes from Burleigh County stated that the surveyors in Burleigh did not know if they were licensed or not in North Dakota.

Mueller asked how long it would take to get the zone board up and working on the project of adding zoning. Mueller would like to see the process start of forming the zone board. Walsh stated a motion had been made to reactivate the zoning board. Commission reminded those in attendance that the zoning board is not reestablished as a CO2 committee and has to address all issues.

Radermacher stated that her job is to ensure that the Commission follow the law in all that they do. Radermacher feels that at this point, she cannot encourage the Commission to do anything other than what they have done at this point.

Discussion followed concerning the Public Service Commission meetings and the need for the landowners to plead their case at the meetings.

Klipfel felt the counties should join together to fight the pipeline as a whole. Klipfel felt the group attorney costs would be minimal. Meyers stated in his opinion, the court is the only one that can stop them. The court could file a cease-and-desist order.

Hoffman stated he felt that the county should not just roll over. Just because they have more money does not mean the county can't do something.

Holm stated he talked with an Emmons County Commissioner. Emmons County already had regulations in place and therefore their moratorium had teeth to it to stand up in court.

Walsh thanked the group for coming.

Sheppard requested a second meeting on December 28th to pay any final bills for the end of the year. The time was set for 9:00 am.

Tax Director Don Flaherty joined the meeting at 2:15 and gave handouts to the Commission.

The handouts were the updated values for mobile home values for 2023. Flaherty's recommendation would be to keep the rates the same with the exception of the category of below average single wide mobile homes. The rates have decreased, but the rate for below average single wide mobile homes have increased. Carlson made a motion to use the same rates as last year, with the exception of the below average single wide. Holm seconded. Roll call vote with Walsh yes; Roberts yes; Holm yes; Carlson yes. Motion carried.

Roberts made a motion to open the Homestead Credit abatement hearing. Holm seconded. Motion carried.

Flaherty explained that it was a late filing of a homestead credit application. The resident will receive 40% homestead credit. The taxes are still collected by the County, by the State of North Dakota and not the taxpayer.

Roberts made a motion to approve the abatement. Holm seconded. Roll call with Roberts yes; Walsh yes; Carlson yes; Holm yes. Motion carried.

Holm made a motion to close the hearing. Carlson seconded. Motion carried.

Sheppard presented two Quit Claim deeds for signature. The two parcels are for parcels were repurchased before the tax sale. Roberts made a motion to sign the deeds. Carlson seconded. Roll call with Carlson yes; Holm yes; Roberts yes; Walsh yes. Motion carried.

Discussion followed concerning the maintenance of the roads. No action was taken. Roberts made a motion to adjourn at 3:10.

Commissioner Meeting December 20, 2022

Commissioner John Hokana called the meeting to order at 9:45 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. Clerk of Court Andi Schimke and Deputy Auditor Stormy were also present via electronic means. The media was not present. The Pledge of Allegiance was recited.

Routes blades go on Schedule of road projects Legislator meeting Bridge on County Road 8 update

Walsh updated the Commission on a meeting he attended Monday December 12th with several legislators from the local legislative districts, Agriculture Commissioner Doug Goehring, resident Drew Courtney representing the corn growers' association, and a representative from the company who is planning to building a fertilizer plant in the area. Discussion at the meeting included the need for CO2

for the fertilizer plant. Walsh stated also that District 28 Representative Mike Brandenburg stated the need for an adjustment on the Prairie Dog funding and the buckets used for the State General fund.

States Attorney Kim Radermacher joined the meeting at 10:00 via electronic means.

Roberts made a motion to approve the draft of the December 6th minutes with corrections. Holm seconded. Motion carried.

Holm made a motion to approve the vouchers presented by Sheppard. Walsh seconded. Roll call vote with Roberts yes; Holm yes; Carlson yes; Walsh yes; Hokana yes. Motion carried.

Walsh made a motion to approve the financial report for November 2022. Roberts seconded. Motion carried.

Sheriff Chris Estes and Deputy Sheriff Kyle Johnson joined the meeting at 10:14.

Estes introduced Johnson, who was sworn in last week. Estes discussed with the Commission activity during the storm last week. The side-by-side was used to rescue people stuck during the storm, specifically six on Thursday night alone.

Treasurer Wonada Lematta joined the meeting at 10:30 to discuss bids received on the purchase of a CD. Walsh made a motion to purchase a 12-month CD from BankNorth at 3.90% interest, in the amount of \$1,000,000. Holm seconded. Roll call with Carlson yes; Holm yes; Roberts yes; Hokana yes; Walsh yes. Motion carried.

Tax Director Don Flaherty joined the meeting at 10:30 for the omitted tax hearing. Roberts made a motion to open the omitted tax hearing. Carlson seconded. Motion carried.

Flaherty presented two parcels that should be charged additional taxes. The first parcel has a newly erected house on it that was not included in the value. The second parcel has a quonset on the property that is no longer used for agricultural purposes and therefore should be taxed. Roberts made a motion to adjust the values on the two properties to include the two adjustments. Carlson seconded. Roll call with Hokana yes; Walsh yes; Carlson yes; Holm yes; Roberts yes. Motion carried.

Walsh made a motion to close the omitted tax hearing. Holm seconded. Motion carried. Carlson made a motion to open the abatement hearing. Holm seconded. Motion carried.

Flaherty presented late filings for homestead credit. One parcel is a 40% reduction for tax year of 2021. The second parcel is 100% reduction for tax years of 2021 and 2022. Flaherty reminded the Commission that the county receives these taxes from the state, not the resident. Walsh made a motion to approve the homestead credits. Holm seconded. Roll call with Holm yes; Carlson yes; Walsh yes; Hokana yes; Roberts yes. Motion carried.

Holm made a motion to close the abatement hearing. Roberts seconded. Motion carried.

Flaherty presented the ag land values received from the state for 2023. Dickey County's value is 6.89% higher over last year's value. County is required to be at an average of a minimum of 90% of that number to be in compliance. In the past, Dickey County has averaged at 93% of that number, but were at 95% in 2022. Flaherty will need to know where the Commission would like to be at by the beginning of 2023. Discussion followed concerning the difference in cropland and noncropland. A consensus was made to target for 92 to 93% of the number from the state. This correlates to an average increase in ag land of 3.22%.

Administrative Assistant Colleen Rithmiller joined the meeting at 10:30, via electronic means. An update was given for the 5-county meeting held December 8th. Sheppard will forward the

Highway Superintendent Jeff Hagen, Highway Foreman Daryl Lematta, and KLJ Engineer Bryan Tykwinski joined the meeting at 11:08.

Tykwinski presented pictures of the bridge on County Road 8, just north of County Road 3. Discussion followed concerning the work completed on the bridge in 2019, when the abutments were replaced. The beams show no damage during the pre-design of the project. Large chunks of the beams are now missing. Installation of insulation shows that the damage was there at the time the abutments were replaced. Discussion followed concerning the use of concrete beams versus steel beams. Carlson asked if steel beams could be installed to support the bridge until the beams can be replaced. Tykwinski will look into the matter. Discussion followed about if the engineer and construction firm that completed the project in 2019 need to be held accountable for the issue. All agreed that for the best interest of the county, pictures from post construction inspection need to be reviewed. Hagen will work with Tykwinski and Radermacher on compiling a letter to be sent to the engineering firm requesting the pictures after the completion of the project. Tykwinski will complete the paperwork to get the project on the schedule for next year.

Tykwinski presented a draft of the Guelph Road, with what work would need to be done on the road. Tykwinski stated that it may require some culverts to be extended or replaced.

DES/911 Coordinator Charlie Russell joined the meeting at 11:10.

draft of the minutes from the meeting to all the Commissioners.

Hagen completed research on the requirement of having motor grader drivers having a CDL license or not. Sheppard also had requested information from the NDACo on the issue. A motor grader driver is not required to have a CDL. Discussion followed concerning the pay scale, which currently doesn't differentiate between having a CDL and not having a CDL. Walsh made a motion to change the salary schedule to include a line for those highway machine operators that have a CDL and those that do

not, when the salaries are reviewed in 2023. Holm seconded. Roll call vote with Walsh yes; Carlson yes; Holm yes; Roberts yes; Hokana no. Motion carried. Any upcoming advertising for new employees will state CDL preferred.

Holm made a motion to allow the one employee that was hired, assuming they would test and receive their CDL, to continue as motor grader operator without a CDL. Carlson seconded. Roll call vote with Walsh yes; Carlson yes; Holm yes, Roberts yes; Hokana no. Motion carried.

Hagen informed Commission that Lematta is planning to retire this spring, but would like to work part time. Hagen stated that if the county could get another blade, then Lematta could assist during the busy time. Discussion followed concerning the viability of that option. Walsh suggested that the current staff work 50 hours each week, instead of the 40 they are currently working. Hagen stated that it will be hard for Lematta to find a blade to use during the busy times, as they are all in use. Roberts stated he felt that the county needs to take advantage of the knowledge Lematta has with all the years he has worked for the county.

Holm requested information from Hagen on the route for each of the blade operators. Hagen stated each operator has an area they cover. Holm stated he saw a road where there was just a hole punched through the drift on the road. Discussion followed concerning the use of the snow blower, if the situation gets worse, which is not a speedy process.

Carlson asked Russell about if the county needed to declare an emergency from this storm. Russell felt that the county should wait until after the first of the year. Once the Commission know how the winter is progressing, a decision can be made at that time.

Hagen discussed with the Commission about advertising for a new person to replace Lematta when he retires. Hagen stated that Lematta has not set a date, but a decision was made to advertise for the position so that it would allow training time before Lematta retirees.

Walsh requested a report from the Highway Department on the number of overtime hours for the last summer. A decision was made to complete this report for more than one year, as weather conditions could affect that report greatly.

Sheppard stated that the term of John Hokana on the South Country Human Services Zone Board is expiring. Walsh stated that he would be interested in filling that roll. Walsh stated he would want to be removed from the South-Central Regional Council board, to fill this roll. Hokana made a motion to appoint Walsh to the South Country Human Services Zone board. Holm seconded. Roll call vote with Hokana yes; Roberts yes; Holm yes; Carlson yes; Walsh yes. Motion carried.

A decision was made to move the July 4th Commissioner meeting to July 5th in 2023.

Discussion followed concerning a section line issue that had been received by Sheppard from an attorney. Radermacher will look into the issue further.

Roberts made a motion to adjourn at 1:25 pm.

Special Commissioner Meeting December 28, 2022

Commissioner Jerry Walsh called the meeting to order at 9:10 am. Also present were Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited.

Sheppard presented a voucher list for final payments to be made in 2022.

A review of the invoices for the installation of light bars and safety equipment on new patrol cars was discussed. The amount has increased significantly. Commission request that Estes look into other options for this work to be completed.

County Agent Breana Kiser joined the meeting at 9:20 to discuss the spray case that was purchased. Kiser stated that this will allow Kiser to demonstrate during pesticide training, the size of droplets on a sprayer and the effect of those droplets. Kiser stated that the state has one that can be used by the county, but the state was unable to tell Kiser where it was located. Kiser made an agreement with LaMoure County Agent to share in the cost of this item so they can both use during training. Oakes Public School has also requested to use it for their ag class. Kiser stated it will be stored in her office, and not out in the elements.

Roberts made a motion to approve the vouchers. Holm seconded. Roll call with Carlson yes; Holm yes; Roberts yes; Walsh yes. Motion carried.

Carlson made a motion to approve the vouchers for the Health District. Holm seconded. Roll call with Roberts yes; Walsh yes; Carlson yes; Holm yes. Motion carried.

Roberts made a motion to adjourn at 9:30 am.
