## Commissioner Meeting February 1, 2022

Commissioner John Hokana called the meeting to order at 9:00 am. Present were Marke Roberts, Joel Hamar, Dean Simek, Jerry Walsh and Chairman John Hokana. The media was not present. The Pledge of Allegiance was recited. Deputy Auditor Stormy Bertsch and Treasurer Wonada Lematta were present, via electronic means.

Additions to the agenda

Changes made to the minutes every meeting

Park Board meeting to review mower quotes

Roberts made a motion to approve the draft of the minutes from January 18<sup>th</sup> with corrections as the official minutes of the January 18<sup>th</sup> meeting. Hamar seconded. Discussion followed concerning comments made concerning the changes made to the minutes at each meeting. The minutes are considered a draft until the meeting finalizes the minutes with changes in wording or with more clarification. Motion carried.

Walsh made a motion to approve the vouchers for payment, with the addition \$100,000 to Dakota Plains Credit Union for the purchase of a CD and the removal of \$1,763 from the bill from Starion Insurance, as that will be paid by Health District. Simek seconded. Motion carried.

Commission discussed a letter received from the ND Department of Water Resources concerning the Oster Dam. Sheppard stated she has forwarded the letter to the Dickey County Water Board.

Walsh made a motion to allow the Treasurer to move Dickey County Water Board funds of \$100,000 from a CD at Starion Bank to a CD at Dakota Plains Credit Union, per the Water Boards request. Roberts seconded. Motion carried.

Park Board members Cary Wertz and Bob Schmidt joined the meeting via electronic means for a Park Board meeting to discuss the purchase of a mower for the Park Board. Discussion followed concerning the discrepancy in the quotes between Green Iron and RDO Equipment. The Commission prefer to keep purchases within the county, but feel that the discrepancy in price is too great. Schmidt made a motion to purchase the lawn mower through RDO Equipment, with no trade-in. Simek seconded. Motion carried. Hamar will get Dickey County on the list for the new mowers being delivered probably in April or May.

Sheppard presented the board positions that are expiring at the end of 2021. Sheppard reported that Norman Haak had resigned as of the January 19<sup>th</sup> meeting of the Dickey County Water Board. His term was to expire in 2025. Sheppard had received notice from John Quandt of his willingness to serve on the Board. Hamar made a motion to appoint John Quandt to fill the unexpired term of Norman Haak. Roberts seconded. Hokana thanked Norman Haak for his years of service on the Board. Motion carried.

Sheppard stated that Don Zimbleman was willing to serve another term on the Water Board. Walsh made a motion to appoint Zimbleman to a 5-year term on the Water Board. Simek seconded. Motion carried.

Sheppard stated the term for the County Park Board was for Cary Wertz, who has agreed to continue to serve on the Park Board. Hamar made a motion to appoint Cary Wertz to a 3-year term to the County Park Board. Walsh seconded. Motion carried.

Sheppard stated the term for the County Weed Board was for Brandon Carlson, who has agreed to continue to serve on the Weed Board. Roberts made a motion to appoint Carlson to a 5-year term on the County Weed Board. Simek seconded. Motion carried.

Sheppard stated that Lauri Wang was resigning from the Dickey/Sargent Housing Authority Board. After Sheppard stated that she would be willing to serve, Hamar made a motion to appoint Sheppard to fill the unexpired term of Lauri Wang. Walsh seconded. Motion carried.

Sheppard requested a decision on the fees charged for liquor and beer license fees for those establishments not in city limits. The current fee schedule is \$200 per year for the alcohol license and \$100 per year for the beer license. Simek made a motion to keep the fees the same as in 2021. Roberts seconded. Motion carried.

Sheppard presented a raffle application for the Ellendale Country Club with drawings in April to help replace aging equipment and grass seed. Walsh made a motion to approve the permit and to waive the fee. Simek seconded. Motion carried.

IT Consultant Jamie Nelson joined the meeting to discuss e-mail accounts for the Commissioners and to update the Commission on phishing e-mails. A decision was made to create nd.gov e-mail accounts for each Commissioner. Nelson will start the process to get the e-mails set up and will assist the Commission with the new e-mails at the February 15<sup>th</sup> meeting.

The meeting went into recess at 10:30 and returned at 10:45.

Sheppard stated the Job Development Authority Board was missed when appointing Board Members for another term. Sheppard updated the Commission on the positions to be appointed, which are Jeff Petersen, Wanda Sheppard, Oakes School Board member Sonia Meehl, Ellendale School

member Cresta Miller, Allan Glynn representing the Townships of Dickey County, and Don Flaherty representing the City of Ellendale. Simek made a motion to accept these appointments. Hamar seconded. Motion carried.

Sheppard requested a motion to have the following measure placed on the ballot for the June 14th, 2022 Primary Election. This measure is required because of changes made in the 2015 Legislative Session on Senate Bill 2144.

"As per N.D.C.C. 57-15-06.7 (5), shall the governing body of Dickey County continue the additional 10 mills for County Roads and Bridges above the 10-mill levy limitation set out in the N.D.C.C. Chapter 57-15-06.7 for a total of 20 mills?

Yes – Means you approve the measure as summarized above.

No – Means you reject the measure as summarized above."

Simek made a motion to place the motion on the ballot for the June 14, 2022 Primary Election. Roberts seconded. Sheppard will present promotional material for the paper at the next Commission meeting. Motion carried.

KLJ Engineer Bryan Tykwinski joined the meeting at 11:00 via electronic means. Tykwinski updated the Commission on the status of the County Road 8 paving project, which the plans have been submitted to DOT. The estimate is close to the projected cost presented earlier in discussions about the project. The schedule for the County Road 8 project and the bridge replacement located 3 miles east and one mile north of Monango are on schedule. Discussion followed concerning the additional cost of the Texas underseal that is included as an option on the County Road 8 project.

Roberts made a motion to adjourn at 11:53.

## Commissioner Meeting February 15, 2022

Commissioner John Hokana called the meeting to order at 9:35 am. Present were Marke Roberts, Joel Hamar, Dean Simek and Chairman John Hokana. Jerry Walsh was in attendance via electronic means. The media was not present. The Pledge of Allegiance was recited. Also in attendance were resident Cindy Bagley in person, and States Attorney Kim Radermacher and Deputy Auditor Stormy Bertsch via electronic means.

Additions to the agenda

CO 2 pipeline and Summit Carbon Solutions

Hamar made a motion to approve the draft of the minutes from the February 1<sup>st</sup> meeting with corrections, as the official minutes of the February 1<sup>st</sup> meeting. Simek seconded. Motion carried.

Sheppard presented additions to the voucher list of \$51.17 to Central Business Solutions for copier rental in the Human Services office, \$1,990.26 in legal fees to Ohnstad Twichell for the Dickey County Water Resource Board, and \$740.00 in engineering fees to Moore Engineering for the Dickey County Water Resource Board. One correction was made to remove a duplicate invoice to Crawford Truck and Equipment Inc. in the amount of \$122.72. Roberts made a motion to approve the vouchers with the corrections listed above. Simek seconded. Motion carried.

Simek made a motion to approve the financials for January 2022. Roberts seconded. Motion carried.

Administrative Assistant Amy Mittleider joined the meeting at 9:50 to update the Commission on grant work that Mittleider is currently working on.

County Agent Breana Kiser and Family and Community Wellness Agent Danielle Dinger joined the meeting to remind Commission of their performance review Thursday, February 17<sup>th</sup> at 10:30, if any of the Commission would like to attend. Dinger also informed the Commission of a Lunch and Learn that is scheduled for March 16<sup>th</sup> and April 20<sup>th</sup> at the Growing Small Towns building in Oakes. Discussion followed concerning the availability of items specific to 4-H in Dickey County and the need to purchase things such as that outside of Dickey County.

Clerk of District Court Andi Schimke joined the meeting at 10:05 to update the Commission on the grant approved to replace some of the chairs in the courtroom and the replacement of blinds to reduce glare and absorption of sound in the Courtroom. Schimke will place the orders to replace the items now that the grant has been approved.

Schimke presented the signed copy of the Court Services Contract with the City of Oakes. The changes that were discussed at the December 7, 2021 meeting. City of Oakes contract has been received and City of Ellendale contract should be received after the next City Council meeting. Roberts made a motion to sign both contracts, when received by the two cities. Hamar seconded. Motion carried.

Schimke discussed with the Commission the court services agreement between Dickey County and the state of North Dakota on funding of the Clerk of Courts office. Hamar made a motion to continue contracting with the state of North Dakota to receive reimbursement for providing clerk services for the 2023-2025 biennium. Roberts seconded. Motion carried. Risk Manager Cresta Miller and Tax Director Don Flaherty joined the meeting at 10:22. Miller discussed with the Commission a quote received from Rough Rider Industries for the replacement of the tables in the Commission room. The quote was in the amount of \$2,448, which is less than half of the price of ordering the same on-line. The quote included delivery and setup. A decision was made to have Miller tape off the dimensions on the floor to see how it will fit in the room and it will be discussed at the next Commissioner meeting, March 1<sup>st</sup>.

Highway Superintendent Jeff Hagen joined the meeting at 10:38. Treasurer Wonada Lematta, DES/911 Coordinator Charlie Russell, and KLJ engineer Bryan Tykwinski joined the meeting at 10:50.

Flaherty presented information to the Commission concerning ag land values for the 2022 tax year. Dickey County's average value for ag land was at 93.04% of the required value set by the state of North Dakota in 2021. Dickey County is required to average their values between 90% and 100% of the value the State of North Dakota places on Dickey County. The state value has dropped, bringing the average value at 97.32% of the required value. Upon the recommendation of Flaherty, a decision was made to equalize the values to be an average of 95%.

Flaherty presented residential sales ratios for 2021. Based on the sales of the past year, our average is at 88.4% of the sales ratio from residential sales in 2021. Dickey County is required to average the values between 90% and 100% of the sales ratio for sales in the county. A minimum average of increase of 2% will be required to meet the state requirement. Upon the recommendation of Flaherty, a decision was made to increase the values to be an average of 93% for residential property in Dickey County.

Flaherty presented commercial sales ratios for 2021. Based on the sales of the past year, our average is at 84% of the sales ratio from commercial sales in 2021. Dickey County is required to average the values between 90% and 100% of the sales ratio for sales in the county. A minimum average of increase of 6% will be required to meet the state requirement. Upon the recommendation of Flaherty, a decision was made to increase the values to be an average of 93% for commercial property in Dickey County.

Flaherty presented a late homestead credit for 2020 and 2021. The resident was not aware of the homestead credit and therefore applied late. Walsh made a motion to approve the homestead credit application. Hamar seconded. Motion carried.

Hagen stated the notice for the bid opening for gravel hauling for the 2022 season is set for March 15. Hagen informed the Commission of hiring a new motor grader driver, Ty Bertsch at the end of January.

Hagen stated that the new motor graders should be arriving late this week or next week.

Hagen stated that Capital I had been in and they had in inventory one-way plows for \$22,500, which was not included in the Road budget.

Discussion followed concerning an invoice approved earlier from Dakota Improvement for snow removal on County Road 1 and 3. Hagen requested the invoice to not be paid until he researches why the work was done. Sheppard will hold bill until Hagen recommends the bill to be paid.

Tykwinski discussed with the Commission the option of the underseal on Dickey County #8. Tykwinski stated that in speaking with other organizations that have used the technology, he has found that others have felt it doesn't offer enough benefit for the cost. A decision was made to not use the underseal on the Dickey County #8 project.

Russell requested information on the mutual aid agreement with Brown County. After some discussion, Russell will check with the States Attorney's office on the status of the agreement.

Hamar requested an update from Summit Carbon Solutions concerning the CO2 pipeline and the status of their project. Sheppard will contact the company and request their attendance at a Commission meeting.

Simek made a motion to adjourn at 11:39.

## Special Commissioner Meeting February 17, 2022

Chairman John Hokana called the meeting to order at 1:35 pm. Present via electronic means were Joel Hamar, Marke Roberts, Jerry Walsh, Dean Simek, and KLJ Engineer Bryan Tykwinski. Present at the Courthouse were Chairman John Hokana and Highway Superintendent Jeff Hagen.

Hokana turned the meeting over to Tykwinski to update the Commission on information received from the ND Department of Transportation. ND DOT has informed Tykwinski that Dickey County could borrow ahead additional years on the federal aid money to help fund the County Road 8 project this summer. The plan is to currently borrow ahead five years, but ND DOT would allow that to be ten years. Discussion followed concerning the ARPA money Dickey County has received, along with the House Bill 1505 money. The Commission were concerned that the borrowing ahead of federal aid money out ten years could hinder road repairs to be done in future years. Dickey County's federal aid balance is \$746,828 and the Dickey County's estimated allotment for 2022 is \$242,190. The County is able to borrow any number of years up to the 10 years. Any money not used from the federal aid fund will have to come from county funds. Sheppard stated that the requirements of HB 1505 require the funds be used on road and bridge projects, but not to be used to pay the county match on federal aid dollars. The HB 1505 money therefore could be used to pay toward the cost of the Highway 8 project that is above and beyond Dickey County's cost share. The ARPA money from the federal government could also be used on this project, but discussion was to not spend all the money on one road and that some funds could be used on other upcoming road projects.

Commission all agreed they didn't feel comfortable borrowing ahead up to ten years. Hamar made a motion to continue the project as it was originally planned without the underseal and to borrow ahead on the Federal aid to 5 years, using a large portion of the HB 1505 and a portion of the ARPA money to fund the balance. Roberts seconded. Roll call with Hamar yes; Roberts yes; Simek yes; Walsh yes; Hokana yes. Motion carried.

Hokana made a motion to adjourn at 2:10.
