Commissioner Meeting March 7, 2022

Commissioner John Hokana called the meeting to order at 9:02 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Clerk of Court Andi Schimke and Deputy Auditor Stormy Bertsch joined the meeting via electronic means.

Walsh made a motion to approve draft of the February 21st minutes with corrections. Holm

seconded. Motion carried.

Discussion followed concerning happenings in the county and upcoming meetings for the Commissioners. A reminder of the Public Service Commission hearing concerning Summit Carbon Solutions pipeline is March 28th at 9:00 am in Gwinner, the township officer meeting is tomorrow, March 8th at CBS' in Ellendale, and mandatory employee training at 9:30 am at the Courthouse on March 22nd.

Roberts made a motion to approve the vouchers, with the addition of one bill to NDSU for work completed on drawings for a possible campground at Pheasant Lake in the amount of \$1,562. Carlson seconded. Roll call was unanimous. Motion carried.

Walsh updated the Commission on the human services zone meeting he attended.

The Health District office staff joined the meeting via electronic means at 9:25. Tax Director Don Flaherty joined the meeting at 9:28.

Holm made a motion to open the abatement hearing. Carlson seconded. Motion carried.

Flaherty received an application for disabled veteran credit for the tax year of 2022. Also presented were two applications for homestead credit. These credits are reimbursed to the county by the state of North Dakota, so there is no affect to taxes collected. Carlson made a motion to approve the applications. Roberts seconded. Roll call was unanimous. Motion carried. Discussion followed concerning the proposed changes to these credits that are on the legislative docket for this year's session.

Holm made a motion to close the abatement hearing. Walsh seconded. Motion carried Carlson updated the Commission on the status of the land the county was looking to purchase to put a boat landing at Tad Lake. The party involved is not willing to sell the land to the county. However, Carlson learned through ND Game and Fish that Game and Fish had approved the installation of a new boat landing west of Carlson's house on the peninsula off County Road 3.

Discussion followed concerning the formation of a County Zoning board. A decision was made to set up a meeting for March 22nd at 1:00 pm in the Commissioner room to establish the board and elect a chairman. Sheppard will send a notice to those selected to serve on the Board, as well as informing States Attorney Radermacher of the meeting.

Resident Allan Gramlow joined the meeting at 10:15.

Gramlow expressed his concern with the load limit change placed on the bridge south of Fullerton on County Road 8. Maple Township is concerned about the increased use of their township roads, until the road is fixed. Commission updated Gramlow on the plans submitted to ND DOT on decreasing that bridge to one lane until the bridge can be fixed.

DES/911 Coordinator Charlie Russell joined the meeting at 10:20. Discussion followed concerning the weather for the upcoming week.

Highway Superintendent Jeff Hagen joined the meeting at 10:45. Hagen updated the Commission on the application for bridge funding to assist in repairing the County Road 8 bridge south of Fullerton. The application has been denied by NDDOT. However, there is a chance that a reinspection will be completed on the bridge, which may lift the limitation.

Walsh made a motion to open the bid hearing to sell the 1987 Oshkosh Snowblower truck that has been listed on BisMan. Roberts seconded. Motion carried.

Five bids were received, with the high bid in the amount of \$18,100. Commission felt that the value of the equipment is worth more than that. Discussion followed that wording on the advertisement is that county has the right to accept or reject all bids. Roberts made a motion to reject all bids and no sale the equipment. Walsh seconded. Roll call vote was unanimous. Motion carried. Sheppard will inform bidders of the rejection of all bids.

Walsh made a motion to close the bid hearing. Roberts seconded. Motion carried.

Asphalt Zipper representatives Dave Fokken and Dave Stiller joined the meeting via electronic means at 10:45. A short 10-minute video was shown, explaining the use of the machine. Discussion

followed concerning the rebidding of the machine, since we bid it last fall. Sheppard stated she would look into the question. No action was taken.

Roberts requested information on the clearing of County #3C. Hagen stated that the motor grader is clearing as much as they can, but there are spots that are getting hard for the motor grader to clean out. Kinzler Farms has been working to help clear out the problem areas. Kinzlers have a tractor with a snow blower that they can get through those sections.

Hagen presented five utility permits from Dakota Valley Electric to bore under County Road 4, county road 5, and county road 12 at specific intersections. Roberts made a motion to approve the five permits. Walsh seconded. Roll call was unanimous. Motion carried.

Discussion followed concerning the lease of a tractor through ND Association of Counties for 2024. The lease will be for 12 months, and a snowblower should be located that could be attached to the tractor for cleaning roads. Included in the discussion was the decision whether to lease a snow blower or to purchase. The consensus was to look at purchasing a snow blower. Holm made a motion to lease a tractor from NDACo that includes a front mount PTO shaft and a three point hitch for 12 months. Carlson seconded. Roll call was unanimous. Motion carried.

Walsh made a motion to adjourn at 11:55

Commissioner Meeting March 21, 2023

Commissioner John Hokana called the meeting to order at 9:45 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. Clerk of Court Andi Schimke and Deputy Auditor Stormy Bertsch were present via electronic means. The media was not present. The Pledge of Allegiance was recited.

Updates were given to things going on in the county. Jangula, an optometrist from Edgeley, will be servicing Ellendale and Oakes will be getting an optometrist as well. A new daycare has been advertising on Facebook in Ellendale.

Holm made a motion to approve the draft of the March 7th minutes with corrections. Carlson seconded. Motion carried.

Walsh made a motion to approve the vouchers, as presented. Holm seconded. Roll call was unanimous. Motion carried.

Carlson made a motion to approve the financial report from February, 2023. Roberts seconded. Motion carried.

The Health District office joined the meeting via electronic means at 10:15.

Tax Director Don Flaherty joined the meeting at 10:15. Discussion followed concerning the annual tax equalization meeting for 2023. The date has been set for June 8th at 1:00 pm at the Courtroom in the Dickey County Courthouse.

Highway Superintendent Jeff Hagen and resident Dean Simek joined the meeting at 10:25. Walsh updated the Commission on County Day he attended in Bismarck, earlier in March. KLJ Engineer Bryan Tykwinski joined the meeting at 10:35.

The Commission discussed the zoning board, set to meet Wednesday at 1:00. The meeting has been postponed, due to incoming weather. Meeting will be rescheduled.

At the advice of States Attorney Radermacher that the bid was postmarked before the original hearing, the Commission would reopen the bid hearing. Carlson made a motion to reopen the bid hearing on the sale of the snowblower truck. Holm seconded. Motion carried.

The new bid was opened. Roberts made a motion to reject the bid, due to the amount of the bid. Holm seconded the motion. Motion carried. The bid is on file at the Auditor's office.

Carlson made a motion to close the bid hearing. Holm seconded. Motion carried.

Roberts presented a proposal from the Oakes Airport Authority for the use of the snowblower truck. Walsh made a motion to make an agreement with the Oakes Airport Authority for the storage and use of the snowblower truck with an annual renewal. Roberts seconded. States Attorney Radermacher will be requested to put an agreement together based on the proposal and any legal requirements. Roll call vote with Hokana yes; Roberts yes; Holm no; Carlson yes; Walsh yes. Motion carried.

DES/911 Coordinator Charlie Russell joined the meeting at 10:45. Russell updated the Commission on weather and flooding issues. Discussion continued concerning the area in Bear Creek Township that was an issue in 2019. Russell stated that his recommendation is to clean out the area to better allow for the flow of water, to resolve the issue ahead of time.

Russell presented a resolution to declare preliminary flood emergency. This will allow Russell to prepare before the flooding would start. Carlson made a motion to sign the resolution. Roberts seconded. Roll call was unanimous. Motion carried.

Tykwinski stated that no response had been received yet from NDDOT concerning the weight restriction plan for the bridge south of Fullerton. Tykwinski will reach out to NDDOT again.

Tykwinski has had contact with the contractors on the County Road #8 project and the bridge project north and east of Monango. The contractors' plans are to start on the projects as soon as the weather allows them to begin.

Hagen reported to the Commission on the purchase of a snowblower for the tractor. Hagen had received a quote from John Deere for an 8200 Snowblast in the amount of \$32,899 and a bid from Fair Manufacturing in the amount of \$28,900. Discussion followed concerning the differences in the product and what would be best for the county. Holm made a motion to purchase the Snowblast. Carlson seconded. Roll call vote was unanimous. Motion carried.

Hagen discussed with the Commission the retirement of Daryl Lematta and his request to work part time. Holm made a motion to keep Lematta hired during this summer. Roberts seconded. Discussion followed concerning the requirements by ND PERS concerning returning after retirement. Sheppard will check into the requirements. Roll call was unanimous. Motion carried.

Discussion followed concerning the large pothole west of Oakes. Hagen will take material out to fix the problem.

Walsh had requested information on the fuel prices and the possibility of prebuying. A decision was to put a notice in the paper for a bid opening for the next season for the purchase of 20,000 gallons of fuel.

Walsh reviewed his summary of the issue of maintaining roads, from his viewpoint. Walsh included research that he had done on soil stabilizers and the full depth reclamation machinery that the county had seen in a demonstration in 2022. Walsh made a motion to bid a purchase or lease of a full depth road reclamation machine needed to begin grinding, building, widening, and restoring the road integrity on Dickey County #12, Dickey County #3 east of Oakes, and other areas in the county, to prepare these roads for a future seal overlay when funds become available and to continue to use this tool for planned annual restoration of county roads as time, resources, and priorities dictate, with the long-term goal to save the county money and preserve resources while improving overall road quality and safety. Holm seconded the motion. Conversation included what other pieces of equipment would be needed, such as a water truck and a packer. Soil stabilizer, PermaZyme, was discussed with the use of the machine. The question of how many additional staff would be needed and the possibility of using Prairie Dog funding to have all the gravel hauled during the summer completed by an outside source, freeing up staff to work with the reclamation machine. After some discussion, Walsh called for the question. Roll call with Walsh yes; Hokana yes; Roberts no; Holm yes; Carlson yes. Motion carried. Roberts stated that his no vote doesn't mean he won't support the board decision.

Sheppard presented the application for a beer and liquor license for the Kulm Community Club. Holm made a motion to approve the application. Carlson seconded. Roll call was unanimous. Motion carried.

Discussion concerning Senate Bill 2239 and House Bill 1040 were discussed and the effect the bills would have on the County budget and the hiring of staff. A decision was made to ask the current employees to comment on the two bills, before a decision was made about a resolution of opposition or in support.

Walsh discussed the use of the RazorTracking devices. After some discussion about the information the Commissioners have been able to use, Carlson made a motion to purchase two units that can be installed in two more machines, at a cost of \$300 each per year. Roberts seconded. Roll call vote was unanimous. Motion carried.

Carlson made a motion to adjourn at 1:30 pm.
