## Commissioner Meeting May 2, 2023

Commissioner John Hokana called the meeting to order at 9:05 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Clerk of Court Andi Schimke was present via electronic means.

Walsh and Hokana updated the Commission on the housing meeting they attended in Oakes on April 19<sup>th</sup>. Discussion was good, but the need for child care is an issue as well as the housing,

Roberts made a motion to approve the draft of the minutes from April 18<sup>th</sup> with corrections. Holm seconded. Motion carried.

Carlson made a motion to approve the vouchers, as submitted. Holm seconded. Roll call was unanimous. Motion carried.

Health District joined the meeting at 9:23 and States Attorney Kim Radermacher at 9:30, both via electronic means.

Commission reviewed some of the issues with the County's Policy Manual that need to be reviewed and updated by the Commission. Discussion followed concerning employee handbooks in other counties, and the consistency between the counties. Sheppard stated that the policies that have been discussed between different counties show there are few similarities between counties. Areas discussed were performance evaluations and timekeeping. Several Commissioners felt that the department heads should return to completing performance reviews.

Tax Director Don Flaherty and landowner Gary Hoffman joined the meeting at 10:00. Roberts made a motion to open the abatement hearing. Holm seconded. Motion carried.

Flaherty reported that this is to remove a building off the assessment for this property, as it was assessed on the wrong parcel. The building has been placed on the correct property, and this will clean up the issue. Walsh made a motion to approve the abatement. Roberts seconded. Roll call was unanimous. Motion carried.

Flaherty presented a homestead credit abatement on one parcel for the tax years of 2021 and 2022. The abatement is a 100% tax credit for the resident. Dickey County receives this money from the State of North Dakota. Holm made a motion to accept the homestead credit application. Carlson seconded. Roll call was unanimous. Motion carried.

Holm made a motion to close the abatement hearing. Carlson seconded. Motion carried. Flaherty provided a list of five appointments needed for the Job Development Authority (JDA) board. A new appointment will need to be made to replace prior Commissioner Dean Simek with another Commissioner. Simek has agreed to stay on the JDA board serving as a representative for small cities. Carlson volunteered to serve on the JDA board. Including Commissioner Carlson, the other board members are Gary Schnell for Oakes Enhancement, Dean Simek for small cities, Bridget Henning for Ellendale Industrial Development, and Trista Gemar as member at large representing financial institutions. Roberts made a motion to appoint Carlson, Schnell, Henning, and Gemar to the JD Board. Holm seconded. Roberts made a motion to appoint Dean Simek to fill the unexpired term representing small cities. Carlson seconded. Motion carried.

Summit Carbon Solutions had called to cancel. Hoffman spoke with the Commission about a federal hearing May  $31^{\text{st}}$  and June  $1^{\text{st}}$  in lowa concerning pipeline hazardous material safety. Roberts stated that his proposed ordinances that he would like to be pursued. Roberts stated that the setback ordinance needs to be pursued specifically because of the pipeline.

Sheriff Chris Estes, DES/911 Coordinator Charlie Russell, and Highway Superintendent Jeff Hagen joined the meeting at 10:30.

Discussion continued concerning the depth of the pipe under the roads and if 48 inches is enough. The use of our current road use permit was also discussed. A decision was made that the current permit application is not conducive to the project and needs to be revised. Radermacher made a clarification to the Commission on zoning versus the Commission making a resolution. A decision was made that Radermacher and two Commissioners would work together to revise the road use agreement. Carlson and Roberts agreed to work with Radermacher on this revision. Hagen requested to be included and the Commission agreed.

Estes reported to the Commission on traffic stops for the patrol cars in April. Load limits on township roads should be posted by the township, if they are different than those of the county.

KLJ Engineer Bryan Tykwinski joined the meeting at 11:03.

Environmental Services employee Dan Blondo joined the meeting at 11:05 to discuss trees in the north lawn, that were needed to be pruned. A decision was made to pull what is there now, and to work with the County Agent's office to place something there to replace them.

Treasurer Wonada Lematta joined the meeting at 11:08 and informed the Commission that their office would be closed May 12<sup>th</sup> starting at approximately 3:00 pm. Signs will be posted.

Russell presented a resolution for a burn ban in Dickey County. The resolution is the same as last year. Carlson made a motion to sign the resolution. Holm seconded. Roll call was unanimous. Motion carried. Commission requested clarification on what is to occur if there is a controlled burn. When it is confirmed a burn day within the limitations of the burn ban, Russell stated that the individual is to contact the fire department, the Sheriff's office, or Russell to notify them of the control burn.

Russell informed the Commission that information has been received from ND DES concerning reporting of damage due to flooding. Russell stated that he has not seen a lot of damage, other than gravel over wash. The information has been sent to all townships.

Tykwinski updated the Commission on the bridge project north and east of Monango. A small concrete pour should be done this week on the intermediate diaphragm and the contractor plans to pour the deck the week of the May 15<sup>th</sup>. This is dependent on the lifting of load limits.

Tykwinski stated that the paving of County Road 8, starting 1 mile south of County Road 3 to the County line, will start as soon as load limits are lifted.

The bridge south of Fullerton on County Road 8 was discussed. An e-mail with pictures was received from Interstate Engineering concerning the damage to the beams. More information is coming from them on the repair of the beams.

Hagen discussed with the Commission about extending the current propane bid to end in March, 2024. The next bidding for propane would cover the time period of April 2024 through March 30, 2025. Carlson made a motion to extend the propane bid to March 30, 2024. Roberts seconded. Roll call was unanimous. Motion carried.

Hagen presented contracts for blading and snow removal from townships that have turned in their contract signed. Holm made a motion to sign the contracts. Walsh seconded. Discussion followed about all townships receiving the contract, and not just those that have not used the county in the past. Roll call was unanimous. Motion carried. Discussion followed concerning the time frame on the contracts and the possibility of have contracts for more than just one year.

Roberts stated a decision needed to be made as to the hourly rate that would be paid to the highway employee retiring next month, when he returns to work as a temporary part time blade operator without benefits. The employee has been completing spot repairs on some roads and pulling in the shoulders. Roberts stated that there was a big difference on the two roads he had looked at.

Based on the employee's current rate of pay and the cost of benefits to that employee, Carlson made a motion to pay the employee \$48.38 per hour for the job as a temporary part time blade operator without benefits. Roberts seconded. Roll call was unanimous. Motion carried. Discussion followed concerning the possible need for a packer for the spare motor grader.

Walsh expressed the need to start planning for what work could be done on County Road 12 and County Road 3 east of Oakes this year. The Asphalt Zipper will most likely not be here until August and a decision will need to be made whether a soil stabilizer and/or a calcium chloride will be used. Hagen and Tykwinski will work on calculating comparative costs for both options. No action was taken.

Walsh requested information from Radermacher on the salt/sand building contract with the city of Ellendale. Radermacher stated she will simplify the contract and get it to the city for their approval. Carlson motion to adjourn the meeting at 12:35.

## Commissioner Meeting May 16, 2022

Commissioner John Hokana called the meeting to order at 9:45 am. Also present were Jerry Walsh, Kacey Holm, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Commissioner Brandon Carlson was unable to attend. Health District employee Kerry Waldo and Clerk of Court Andi Schimke were in attendance via electronic means.

States Attorney Kim Radermacher joined the meeting at 9:50.

Radermacher presented to the Commission the proposed resolution setting forth requirements to obtain a permit for county road crossings by pipelines. Walsh stated he had attended a property

rights meeting in Leola and felt the Commission is not doing enough to protect land owner rights concerning pipelines. Discussion followed concerning what the county can do, as the Commission has control over the county roads and not the rights of the landowner. Walsh stated he felt that the Commission should include a 90% to 100% requirement of volunteer landowner easements before the County would sign any road use permits. Roberts stated there are four households in the Oakes area, where the pipeline will go close to their homes but are on someone else's land, which the homeowner has no say as it is not on their land. Discussion continued concerning a need to include a setback in this resolution or a different resolution. Radermacher stated that legally, it would be best to have a different resolution for the setbacks versus the permit for road crossings.

Walsh made a motion that a separate resolution be compiled, adding a contingency on pipeline road crossing be approved once 100% voluntary landowner easement have been received, a resolution concerning setbacks of 440 yards from all places of residence unless waived by the landowner, and corrections made to the proposed resolution presented earlier. Roberts seconded. Roll call was unanimous. Motion carried.

DES/911 Coordinator Charlie Russell joined the meeting at 10:30, Sheriff's office via electronic means at 10:32, Sheriff Chris Estes at 10:36, and Highway Superintendent Jeff Hagen at 10:37.

Family and Community Wellness Agent Danielle Dinger and Intern Abigail Peterson joined the meeting at 10:45. Dinger introduced Peterson to the Commission and explained that Peterson will be interning with Dinger this summer.

Walsh made a motion to approve the draft of the minutes with changes. Holm seconded. Motion carried.

Holm made a motion to approve the vouchers as submitted. Walsh seconded. Roll call was unanimous. Motion carried.

Risk Manager Cresta Miller joined the meeting at 10:45 to discuss with the Commission about near misses that are not reported to Miller. Discussion included the memo that each employee signs each year that states near misses have to reported. A decision was made to put an insert in the next paycheck reminding employees of the rules.

Treasurer Wonada Lematta joined the meeting at 10:50, and KLJ Bryan Tykwinski joined the meeting via electronic means at 11:05.

Roberts made a motion to approve the April 2023 financials, presented by Sheppard. Walsh seconded. Roll call vote was unanimous. Motion carried.

Radermacher requested a policy be put in place concerning the procedure for Asset Forfeiture funds. Radermacher stated that financially, a fund has been set up but no procedure had been developed for the handling of such funds. After review of the procedure, Walsh made a motion to accept the procedure. Holm seconded. Roll call was unanimous. Motion carried.

Walsh reported on the Job Development Authority (JDA) meeting held earlier in May. Walsh stated that a presentation had been made by Gary Dathe on behalf of the American Legion. The JDA Board had made a motion to approve a \$25,000 grant and \$25.000 3-year loan to the American Legion., contingent on the approval from the Commission to adjust the 2023 JDA budget from a total of \$71,793 to \$96,793. Walsh made a motion to adjust the budget by \$25,000. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard informed the Commission there were two positions on the JDA that needed to be approved by the Commission. Don Flaherty has resigned from the JDA Board and the city of Ellendale has appointed Melissa Johnson to fill his position. The Oakes City JDA has appointed Cindy Bagley to represent them on the County JDA Board. Holm made a motion to appoint Johnson and Bagley to the JDA Board. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard presented two liquor license transfer applications for the American Legion for two dates in June. Holm made a motion to approve the applications. Walsh seconded. Motion carried.

Estes stated that the City of Ellendale is requesting the use of the traffic radar sign. Estes stated that there are some repairs needed before anyone uses it. Holm made a motion to allow the City of Ellendale to use the county traffic radar sign. Walsh seconded. Roll call was unanimous. Motion carried.

Lematta presented the Treasurer's Pledge and Quarterly report for second quarter, 2023. After reviewing the report, Roberts made a motion to approve the report and have the Chairman sign the report. Holm seconded. Roll call was unanimous. Motion carried.

Tykwinski updated the Commission on the bridge project north and east of Monango, where the bridge deck should be poured next week. The contractor plans to start the paving project on County Road 8 the middle of next week.

Hagen presented two utility permits from Dakota Valley Electric to bore under County Road #10 in sections 34 and 35 in Ada Township. Walsh made a motion to sign the permits. Roberts seconded. Roll call was unanimous. Motion carried.

Discussion followed concerning the gravel plan for this year. Hagen stated they were working on County Road 12 today and plan to move to County Road 5 once that is finished. Discussion followed concerning County Road 14A.

Russell requested a change in the burn ban resolution signed at the May 2<sup>nd</sup> meeting. Due to changes in the law, the resolution needs to be a "restriction", not a "ban." Holm made a motion to have the Chairman and Auditor signed the revised resolution. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard requested a decision from the Commission concerning the increase in health Insurance premiums that will take effect July  $\mathbf{1}^{\text{st}}$ . Walsh made a motion for the County to cover the increase in the employee share, for the remaining months of 2023. Roberts seconded. Roll call was unanimous. Motion carried.

Tax Director Don Flaherty joined the meeting at 12:00 with three abatements. Holm made a motion to open the abatement hearing. Roberts seconded. Motion carried.

The abatements are for filing for homestead credit for two tax payers. Parcel #11048000 is for tax years 2021 and 2022. Parcel #07893000 is for tax year 2022, subject to an eight month prorate. Roberts made a motion to approve the homestead credits. Holm seconded. Roll call was unanimous. Motion carried. Roberts made a motion to close the abatement hearing. Holm seconded. Motion carried.

Holm made a motion to adjourn the meeting at 1:00 pm.
