Commissioner Meeting April 1, 2025

Chair Brandon Carlson called the meeting to order at 9:25 am. Commissioners John Hokana, Jerry Walsh, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. States Attorney Kim Radermacher, Dickey County Sheriff's Office, Applied Digital representative Andrea Mireles, and resident Cindy Bagley were also present via electronic means.

Additions to the Agenda

Auditor/Treasurer combining offices

County Park Bower's Tree service

Holm made a motion to approve the minutes of the March 18th and March 27th meetings, as revised. Walsh seconded. Motion carried.

Holm made a motion to approve the vouchers as presented. Roberts seconded. Roll call was unanimous. Motion carried.

Janitor Scott Peterson and Bowers Tree Service representatives Scott Bower and Alex Bower joined the meeting at 9:35. A Bower presented a quote for the removal of the ash trees from the courthouse lawn. Discussion followed concerning the treatment of the trees versus the removal of the trees. There is a treatment that is available that needs to occur every other year. Bower's recommendation is the removal of the trees. Bower stated that the city has agreed to allow them to take the trees to the dump at no charge. The quote is given in sections but do not have to be completed at the same time. If the Commission would commit to the project, the price is guaranteed until completed. Walsh made a motion to commit to the quote and complete section 1 in 2025, using LATCF funds. Holm seconded. Roll call was unanimous. Motion carried.

The next item on the agenda is to discuss whether the County should consider purchasing real property adjacent to property the County currently owns, and which contains a gravel pit that has been regularly used by the County in the past. The contents of this discussion may be held in an executive session. The legal authority for closing this portion of the meeting is North Dakota Century Code section 44-04-19.1(5), which states in part: "attorney consultation" means any discussion between the members of a governing body and its attorney in instances in which the governing body seeks...to receive its attorney's advice and guidance on the legal risks, strengths, and weaknesses of an action of a public entity which, if held in public, would have an adverse fiscal effect on the entity; as well as North Dakota Century Code section 44-04-19.1(9), which states in part: a governing body may hold an executive session...to discuss negotiating strategy or provide negotiating instructions to its attorney...relative to contracts, which are currently being negotiated or for which negotiation is reasonably likely to occur in the immediate future and which would have an adverse fiscal effect on the bargaining or litigating position of the public entity if held in an open meeting.

At this time, a motion would be in order to discuss the next topic in executive session rather than in an open meeting. Is there such a motion? Roberts made the motion. Any second? Holm seconded. Any discussion on the motion? I'll call the roll. Roll call was unanimous. Motion carried.

The executive session will be recorded, and all members of the governing body are reminded to limit their discussion during the executive session to the announced topic. Any collective decision, collective commitment, or other final action by the governing body must occur after it reconvenes in an open meeting, unless final action is specifically required by law to be taken during the executive session. The prohibition on taking final action during the executive session does not apply to providing guidance or instructions to our attorney or negotiator.

We will now ask the members of the public who are attending the meeting to leave the room. We anticipate adjourning the executive session, and reconvening the open portion of the meeting, at approximately 10:30 am.

The minutes will show that the executive session was adjourned at 10:59 am. The public was invited to return to the meeting after a short break and we are now back in open session.

Hokana made a motion to authorize Carlson and Holm as representatives of Dickey County to proceed to purchase the property up to the agreed upon price during executive session. Roberts seconded. Roll call was unanimous. Motion carried.

Clerk of Court Andi Schimke, KLJ Engineer Bryan Tykwinski, Dickey County Sherriff's Office, and resident Cindy Bagley joined the meeting via electronic means. Highway Superintendent Jeff Hagen, Lorraine Township representatives Keith Hauck, Keith Kronberg, and Scott Moore, along with Retzlaff Trucking representative Brad Retzlaff joined the meeting at 11:05.

Roberts made a motion to open the gravel bid hearing. Holm seconded. Motion carried.

Two bids were received for gravel hauling for 2025 as shown below.

Dakota Improvement – Section 2 only

0 through all miles \$0.28/ton/mile Loading \$0.70/ton Retzlaff Trucking – Section 1 and 2 0 through 9 miles \$3.00/ton/mile 10 through all miles \$0.30/ton/mile Loading \$0.70/ton

Roberts made a motion to accept Retzlaff Trucking's bid for section 1 and Dakota Improvement bid for section 2. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to close the gravel hauling bid opening. Walsh seconded. Motion carried. Hauck spoke with the Commission concerning the state of 74th Avenue and the amount of traffic on that road since the purchase of the land by Webster Scale. Lorraine Township is requesting that the county take over 74th Avenue from Highway 11 to the State Line. The traffic on the road is more than the township can bear. Lorraine Township is requesting that the road be turned into a county road. Radermacher stated that a joint powers agreement between the county and the township may be an option. Hauck stated that Webster Scale has been willing to assist with the maintenance of the road. Discussion included the many townships that have requested the same assistance. Tykwinski stated that the road may be a good option for the flexible funding program that is offered to counties and townships. Tykwinski will work with the township to get their application filled out and filed with the ND DOT within the required timeline. The Commission stated they were not opposed to assisting with extra blading to get the road back in shape until the flexible funding assists with the project. Hauck asked the Commission for advice on an agreement with Webster Scale. Webster Scale would like to widen the road on the west side. Commission reminded Hauck that the road needs to meet the standards set by DOT. Commission stated that Lorraine Township needs to sit down with Webster Scale and work out a documented system that works for both parties. Roberts made a motion to double the amount of blading through the summer, charging at the regular price. Holm seconded. Roll call was unanimous. Motion carried.

Hagen presented a utility permit from Dakota Valley Electric to bore power lines under County Road #8 at the intersection of County Road #8 and 83rd Street. Holm made a motion to approve the utility permit. Walsh seconded. Motion carried.

Hagen presented four township blading agreements with Van Meter, Whitestone, Keystone, and German Townships. The price on the contracts was discussed. The Commission would like to look at two year agreements next year. Holm made a motion to sign the Van Meter, Whitestone, Keystone and German Township agreements. Walsh seconded. Motion carried.

Hagen presented two Load Pass contracts for Porter and Whitestone Townships. Holm made a motion to sign the contracts with Porter and Whitestone Townships. Roberts seconded. Motion carried.

Kedish House Executive Director Kristi Gilbert joined the meeting at 12:03 via electronic means.

Walsh discussed the issue of finding someone to mow at Pheasant Lake. Walsh suggested that maybe the Highway Department could assist with the issue, if need be. The second advertisement will be in the paper for Pheasant Lake, as Wilson Dam has been covered.

Tykwinski reminded the Commission that the bid opening for Divide Township project is Monday, April 7th at the highway shop. The County Road #8 chip seal project bid opening is April 21st at 11:00 at the highway shop.

Sheppard presented the beer and liquor License applications received by the Kulm Country Club. Hokana made a motion to approve the applications. Roberts seconded. Motion carried.

Sheppard presented a gaming permit from the Forman Golf Association for gaming at the Oakes Golf Course. Holm made a motion to sign the authorization. Hokana seconded. Motion carried.

Treasurer Wonada Lematta joined the meeting at 12:15. Walsh presented a few handouts on possible changes for the combining of the Auditor and Treasurer's offices. Discussion followed concerning hiring a county manager and making all positions appointed. The county manager would oversee all offices. This will be discussed further at the April 15th meeting. Discussion was tabled until the April 15th meeting.

Hokana made a motion to adjourn at 12:40.

Commissioner Meeting April 15, 2025

Chair Brandon Carlson called the meeting to order at 9:50 am. Commissioners John Hokana, Jerry Walsh, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard, JETx representative Kris Koch and Applied Digital representative Martin Vega were also present. The media was not present. The Pledge of Allegiance was recited. Dickey County Sheriff's Office, Recorder Kelly Schmidt, States Attorney Kim Radermacher, Deputy Clerk of Court Cresta Miller, Deputy Recorder Lori Wald, and Administrative Assistant Amy Mittleider joined the meeting via electronic means. Walsh made a motion to approve the minutes of the April 1st meeting with corrections. Roberts seconded. Motion carried.

Roberts made a motion to approve the vouchers as submitted. Holm seconded. Roll call was unanimous. Motion carried.

Hokana made a motion to approve the March financial statement. Walsh seconded. Motion carried.

Valley Township Clerk/Treasurer Dale Radermacher joined the meeting at 10:00.

Walsh gave an update on the Human Services Zone meeting he attended. Medicaid numbers have declined. The call center is experiencing a high turnover in staff, due to the nature of the job.

Tax Director Don Flaherty and Treasurer Wonada Lematta joined the meeting at 10:13. Flaherty discussed with the Commission possibly missing a township equalization meeting or two. Flaherty is requesting that Ellendale City Auditor Nicole Kempf, who is a certified assessor, be responsible for any meetings Flaherty may miss, as Deputy Tax Director Kasie Kinzler is not certified at this time. Walsh made a motion to pay Kempf \$150 for each meeting that requires her attendance plus any cost of travel. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to open the abatement hearing. Roberts seconded. Motion carried.

Flaherty presented four parcels with late homestead credit filings. Three of the four parcels include tax year 2023 and 2024. The fourth parcel is for tax year 2024. One parcel has 50% credit for 2023 with an increase to 100% for 2024 tax year. One parcel is 50% credit for both tax years. All the other parcels are 100% for the tax years filed. All applicants fit the guidelines of homestead credit.

Walsh made a motion to approve the abatements as presented. Holm seconded. Roll call was unanimous. Motion carried.

Flaherty informed the Commission about two corrections that need to be recalculated on two parcels. The first will be a refund and the second one will need a portion paid back to the county. Due to the issue was a county error, Flaherty is requesting that the discount received on the incorrect number be honored for the second payment if the payment is received in the next 30 days. Roberts made a motion to approve granting the discount, if payment is received within 30 days. Holm seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to close the abatement hearing. Holm seconded. Motion carried.

Flaherty requested the Commission allow Flaherty to contract with Vanguard Appraisal for assessing the new buildings at Applied Digital. Flaherty stated the cost would be approximately \$215 per hour, with a cap of \$12,000. Walsh made a motion to authorize Flaherty to contract with Vanguard Appraisal for the appraisal on the new buildings at Applied Digital. Hokana seconded. Roll call was unanimous. Motion carried.

Holm and Carlson updated the Commission on the land auction with a gravel pit in Dickey County. The price agreed upon during the executive session was not high enough and the auctioneer would not split the offer. Discussion continued concerning possible changes to the auction. Radermacher advised that the Commission should enter in executive session to discuss matters if something were to change.

Sheppard informed the Commission that the air conditioning unit in the Auditor's office vault appears to have died. The server in the vault needs to be kept cool. Sheppard is requesting authorization to purchase a new A/C unit, if needed. Holm made a motion to authorize Sheppard to purchase a new a/c unit, if needed. Roll call was unanimous. Motion carried.

Discussion followed concerning the combining of the Auditor and Treasurer position that Walsh presented at the March 4th Commission meeting. Also discussed was the plan Roberts presented at the March 18th meeting of changing the Auditor, Treasurer, and Recorder position to appointed and the hiring of a County Manager that would also handle human resource issues. The cost of a Human Resource person was discussed. Walsh stated that a Human Resource person could be appointed with the retirement of either the Auditor or Treasurer. Roberts stated that adding more tasks to one person is not the answer in his opinion. The terms of the current Auditor and Treasurer do not end until 2027. Radermacher stated that to make the changes proposed by Roberts, there would need to be a change in the form of government for Dickey County. No decision was made.

Sheppard presented the software support/license renewal agreement with Software Innovations. Sheppard stated that Software Innovations is under new ownership. Walsh made a motion to sign the agreement. Holm seconded. Roll call was unanimous. Motion carried.

Applied Digital Representative Andrea Mireles joined the meeting via electronic means at 10:50. Water Board members John Quandt and Steve Hanson, Young Township supervisor Jason Hildenbrand, Highway Superintendent Jeff Hagen, KLJ engineer Bryan Tykwinski, and Sheriff Chris Estes joined the meeting at 10:55.

Radermacher submitted the proposed "Consent for Utility Company to cross a public road or section road" form. Radermacher stated it is a more comprehensive agreement and combines overhead crossings and boring crossings to one form. Radermacher has conferred with Tykwinski and the ND DOT on the form. Radermacher stated it is consistent with other counties. The current fee is \$200. Walsh

made a motion to adopt the new consent form for road crossings with a \$200 fee. Hokana seconded. Motion carried. Hagen will have IT Consultant Nelson update the web site.

Hildenbrand informed the Commission the need to replace a culvert at 82nd Street and 89th Avenue between sections 24 and 25. The landowner has paid for the hydrology study. Hansen had informed Hildenbrand about the cost share program with the Water Board and Dickey County, which is a sharing of the cost evenly between the township, county, and the Water Board. Hildenbrand is requesting this funding. Hokana made a motion to approve the use of funds to replace the culvert in Young Township. Roberts seconded. Roll call was unanimous. Motion carried. Water board will discuss the project at tomorrow's meeting. Hildenbrand will get the bill to Sheppard when the project is complete.

Roberts made a motion to open the propane bid hearing. Holm seconded. Motion carried. Three bids were received as listed below.

Holm made a motion to accept the \$1.24/gallon bid from Farmers Union. Hokana seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to close the propane bid hearing. Holm seconded. Motion carried. Sheppard presented the easement for the Divide Township project that Tykwinski had given her. Tykwinski stated it is a permanent easement and a temporary easement that need to be filed with the Recorders Office. Holm made a motion to sign the easements. Roberts seconded. Roll call was unanimous. Motion carried.

Tykwinski informed the Commission that Dickey County 3C and the road to the winery were both denied for the safety program. Tykwinski stated that the best funding for County Road 3C is the flexible funding available through the state or federal aid funding. Discussion included having the highway staff place more gravel on the road and put chloride on it. Hagen stated he would look at that.

Tykwinski discussed with the Commission old easements on the north two miles of County Road #12. Most easements have been found, but have not located those for the north two miles. Tykwinski will send the list to the Recorder and the Auditor to see if anything else can be found. Tykwinski also reminded them of the bid opening on April 21st at the Highway Shop at 11:00 am.

Hagen presented a utility permit from DRN to bury fiber optic cable along Highway #1 in sections 17 and 20 in Divide Township. Roberts made a motion to approve the permit. Holm seconded. Motion carried.

Hagen presented two agreements for township blading for 2025. The agreements are with Valley and Lorraine townships. Holm made a motion to have the Chair sign the agreements. Walsh seconded. Motion carried.

The meeting went into recess from 11:40 to 11:45.

Applied Digital representatives Nick Phillips and Janelle Combs joined the meeting at 11:45. Phillips discussed with the Commission the passage of house bill 1444 and the effect of the bill on the actions to be taken on 87th Avenue in Ellendale Township. Phillips stated there were some things that still need to be worked through. Discussion followed concerning having a joint powers agreement with the city of Ellendale for the first mile of 87th Avenue. Applied Digital is requesting the county continue one more mile through Ellendale Township to the Elden Township line at 96th Street. Elden Township has verbally stated they would agree to have the county take over 87th Avenue to 95th Street and the two miles of 95th Street to Highway 281. Phillips stated that ND DOT has agreed to pay 50% of the cost to pave these roads. Applied Digital would agree to pay the loan payment through a special assessment to pay the balance of the total cost. Phillips stated they are hoping that the project can be completed in two phases.

Phase 1 would be the portion in Elden Township, as they have agreed to allow the county take over that section of road. One thing that will need to be considered is who is responsible for the maintenance of the road. Discussion included adding the road to allow the county to get federal funds in the future. Contingent on Elden Township turning over to the county the roads discussed and the approval of States Attorney Radermacher on all paperwork, Walsh made a motion to authorize Dickey County to take steps necessary to take over the roads in Elden Township (Phase 1) with the development of a joint powers' agreement with Elden Township for the first two miles on 95th Street from Highway 281 west and one mile south on 87th Avenue. Holm seconded. Roll call was Roberts yes; Carlson yes; Holm no; Hokana yes; Walsh yes. Motion carried.

Based on the framework of HB 1444 which is effective August 1, 2025, Walsh made a motion for the county to work with the city of Ellendale and Ellendale Township to take steps necessary the development of a joint powers' agreement with the City of Ellendale and the takeover of land in Ellendale Township. Holm seconded. Roll call was Walsh yes; Hokana yes; Holm yes; Carlson yes; Roberts no. Motion carried. Combs agreed to start the process and forward to Radermacher for her review.

Sheppard presented a request from the city of Ellendale for support on a grant for the purchase of a new police car. Roberts made a motion to sign the support letter. Walsh seconded. Motoin carried.

Estes informed the Commission of a possible candidate for a deputy sheriff who decided to not interview because of the lack of housing in the area. Estes will be applying for the highway safety grant, as well.

Estes discussed with the Commission on the new building and the need for an impound lot. Based on the placement of water after the last snow, more material will be need to be added if the lot would be placed on the east side of the building. Estes feels the north side would work better. Discussion included the motion made earlier to have Estes investigate putting an outside fencing area and the cost. Discussion went on to discuss the large door and the door opener that is not installed. Sheppard stated that it has been paid for. Hagen and Estes stated they would get that installed. Hokana made a motion to adjourn at 12:40.
