## Commissioner Meeting October 6, 2020

Commissioner Marke Roberts called the meeting to order at 9:00. Present were Thor Sand, Joel Hamar, Dean Simek, John Hokana, and Chairman Marke Roberts. The media was not present. The Pledge of Allegiance was recited.

Additions to the agenda

County Road #3 east of Oakes to cemetery

Basement project

Hokana made a motion to approve the minutes from the September 15<sup>th</sup> meeting with corrections. Simek seconded. Motion carried.

Hamar made a motion to approve the minutes from the budget hearing on September 15<sup>th</sup> with corrections. Simek seconded. Motion carried.

Sand made a motion to approve the vouchers. Hamar seconded. Motion carried.

4-H agent Danielle Dinger joined the meeting at 9:30 to inform the Commissioners on activities this week for National 4-H week.

Sheriff Chris Estes joined the meeting at 9:32. Discussion followed with Estes concerning office and storage space for the Sheriff's office during the basement project.

Tax Director Don Flaherty joined the meeting at 9:45 to discuss the revised bylaws and procedures proposed by the board of Job Development Authority. The discussion followed concerning the inclusion of community enhancement in the bylaws and procedures. After some discussion, Flaherty stated he would revisit the changes discussed, which then would have to be presented to the JDA at their next scheduled meeting in October.

KLJ Engineer Bryan Tykwinski joined the meeting at 10:35.

Hamar made a motion to open the omitted tax hearing at 10:43. Sand seconded. Motion carried. Flaherty stated that this omitted tax is because of farm residency exemption forms were not filled out as requested several times by his office. The Tax Director has not received the required paperwork to establish the farm residency exemption. Per the recommendation of the Tax Director, Hamar made a motion to approve the omitted tax and the property to be put on the tax rolls for the 2020 tax year. Sand seconded. Motion carried.

Hamar made a motion to close the omitted tax hearing. Simek seconded. Motion carried.

Sheppard presented to the Commissioners the status of the 2021 Budget for their final review. Changes were made to decrease some projected expenses for 2020. With the state of the economy, the Commission would like to keep expenses down as much as possible. However, after some discussion for the need of money for road repairs, as well as the basement project which has not been bid at this time, Simek made a motion to approve the budget as presented. Sand seconded. Roll call vote with Hamar yes; Hokana yes; Sand yes; Simek yes; Roberts yes. Motion carried.

Highway Superintendent Jeff Hagen joined the meeting at 11:00. Hagen stated that the road department was still hauling their own gravel. The gravel haulers are done and the last bill has been received. Hagen discussed the mowing of ditches not completed by the land owner. Hamar discussed the policy of bale removal from the ditches. The policy will be reviewed.

Tykwinski discussed with the Commission about the annual Department of Transportation meeting usually held in conjunction with the NDACo conference, which will be done virtually this year. A decision was made to request the meeting be held during the Commissioner meeting on October 20<sup>th</sup>. Tykwinski will check on that and get back to Sheppard.

Sand made a motion to open the request for proposal hearing on the ER project on County Road #1 for 2021. Simek seconded. Motion carried. Sheppard presented a copy of each bid to each Commissioner. Two proposals were received, one from KLJ and one from Interstate Engineering. Sheppard will set up a meeting date with the two firms on October 19<sup>th</sup> and a decision can be made at the meeting October 20<sup>th</sup> for the choice of firms. The interviewing will be completed by the Road portfolio, Sand and Simek, along with Highway Superintendent Hagen.

Hamar made a motion to close the proposal opening. Simek seconded. Motion carried.

Sheppard updated the Commission on the information she had received from other counties concerning carry over of vacation at the end of 2021. Sheppard stated that most counties were not allowing that this year, but also stated that most counties allowed a larger amount of carry over then Dickey County did. A decision was made to ask each department head talk to the Commission as to how they like to see it handled in their department.

Sheppard presented a request of support received from the Anne Carlsen Center for their construction project. Hamar made a motion to support the project. Simek seconded. Motion carried.

Sheppard requested a change in the first meeting in November as it is on Election Day. A decision was made to move the meeting to November 5<sup>th</sup>. The meeting will be held through Zoom and will involve only the approval of vouchers and the bid opening for the basement project.

Sheppard presented a letter from ND Department of Emergency Services letter that needs to be signed in order to receive FEMA funds for the spring 2020 disaster. Simek made a motion to have DES Coordinator Charlie Russell sign the form. Hokana seconded. Motion carried.

Sheppard presented letters from the ND DOT concerning identifying locations for railroad safety in Dickey County. No action was taken.

A delegate for the State Fair Convention needs to be appointed. Sheppard will ask County Agent Breana Kiser. 4-H Agent Danielle Dinger would also be an option.

Sand made a motion to sign the right of way certificate and the bound council agreement, which are required paperwork with the USDA for the loan on the basement project. Simek seconded. Motion carried.

Discussion followed concerning a petition being circulated to get Dickey County #3 east of Oakes to the cemetery to be fixed. After some discussion, Commission would like KLJ to look at the road and to give the Commission a rough idea of the cost of repair of the road at the next Commissioner meeting. Sheppard will contact Tykwinski.

Hokana made a motion to adjourn at 12:30.

## **Special Commissioner Meeting October 8, 2020**

Commissioner Marke Roberts called the meeting to order at 1:47 pm. Present were Thor Sand, Joel Hamar, Dean Simek, and Chairman Marke Roberts. John Hokana was not in attendance. Health District Administrator Roxanne Holm, Health Officer Dr. Tara Mertz-Haak and Regional Epidemiologist Jennifer Schmidt were also in attendance, along with county employees Shirlene Wagner, Stormy Bertsch, Anber Miller, Andi Schimke, Don Flaherty, Cresta Miller, Kerry Waldo, Denise Olson, Deb Anderson, Charlie Russell, Amy Mittleider, and Lauri Uecker. The media was not present. The Pledge of Allegiance was recited.

The meeting was turned over to Holm. Holm updated the Commission on changes made on the map of North Dakota, as Dickey County will be turned to yellow as of Friday October 9th. The change in color lags behind the activity as the change only occurs every two weeks. The Health District's recommendation is to continue business as usual.

Sheppard requested a change, as there is more activity in the Courthouse because of the election in November. The concern is the increase in activity and the health concerns of all employees, specifically the health of the Auditor's office.

Staff offered any concerns they may have. The discussion concerning cases of close contact in the Courthouse. The recommendation of the Health District is to continue social distancing and to wear masks when in contact with anyone within 6 feet. A sign could be posted on the door to encourage people to be courteous and stay behind any protective barriers when visiting offices.

No action was taken.

Sand motioned to adjourn the meeting at 2:17.

## Special Committee Meeting October 19, 2020

A special meeting to interview applicants for preliminary and design engineering 1 for the road project CER-1104(061), PCN 22987 was called to order at 9:05. Those in attendance were Commissioners Thor Sand and Dean Simek, along with Highway Superintendent Jeff Hagen.

The first interview was with Interstate Engineering, who joined by electronic means. Those in attendance from Interstate Engineering were Client Manager Michael May, Lead Surveyor Daren Peterka, and Project Manager Erick Umess. A short presentation was given by Interstate Engineering, and was followed by a question and answer period.

The second interview was with KLJ at 10:00, who joined by electronic means. Those in attendance for KLJ were Project Manager Bryan Tykwinski and Senior Project Engineer Matt Lange. A short presentation was given by KLJ, and was followed up by a question and answer period.

Discussion followed concerning the two firms and the ability of the firm to handle the project. Both firms are comparatively capable of doing the project. A decision was made when ranking the two firms that the job would be awarded to KLJ, as they had the advantage of working on the portion of the project completed in 2020. Sheppard will put a memorandum together to present to the whole Commission at the next Commissioner meeting, October 20<sup>th</sup>.

The meeting was adjourned.

## Commissioner Meeting October 20, 2020

Commissioner Marke Roberts called the meeting to order at 10:01. Present were Thor Sand, Joel Hamar, Dean Simek and Chairman Marke Roberts. John Hokana was not in attendance. Sheriff Chris Estes was also present. The media was not present. The Pledge of Allegiance was recited.

Hamar made a motion to approve the minutes from October 6<sup>th</sup> and October 8<sup>th</sup> with corrections. Simek seconded. Motion carried.

Simek made a motion to approve the vouchers, excluding the voucher to Star Enterprises. Sand seconded. Motion carried. The Star Enterprises voucher will be reviewed with the Road Department later in the meeting.

Sand made a motion to approve the financials from September 2020. Simek seconded. Motion carried

Tax Director Don Flaherty and Treasurer Wonada Lematta joined the meeting at 10:20. Simek made a motion to open the omitted tax hearing. Hamar seconded. Motion carried.

Parcel #11027000 is the former school in Forbes which has been torn down. There is asbestos so the property cannot be developed. There is still value, but it is reduced, as it can only be green space with no time limit. The deed transferring the property states that if the land is developed, the land will go back to the city of Forbes. The transfer of the property is a transfer from exempt to non-exempt. The second parcel is #08249000, which has a house purchased from Trinity Bible College. The transfer of the property is a transfer from exempt to non-exempt. Flaherty stated that both properties have been prorated based on the length of time the property has been non-exempt.

Sand made a motion to approve the values on the two properties, based on the Tax Director's recommendation. Simek seconded. Motion carried.

Hamar made a motion to close the omitted tax hearing. Simek seconded. Motion carried.

Lematta presented a new signature card for First Community Credit Union in Oakes. A motion had been made in December 2019 to update all financial institutions in Dickey County to remove Cheryl Brokaw and add Lematta and Lori Wald to the accounts. Hamar made a motion to sign the updated signature card for FCCU. Simek seconded. Motion carried.

Lematta presented the quarterly Treasurer's report for the Commissioners to review. Sand made a motion to approve the report. Hamar seconded. Motion carried.

The nine properties that will be available for sale at the tax sale November 17<sup>th</sup> for properties where taxes have not been paid were reviewed. The minimum bids were set and will be published according to Century Code requirements.

Sheppard presented the Maintenance Certification for County Federal Aid Project form received from the Department of Transportation. By signing the form, the County is stating they will continue to maintain the roads that the County receives federal dollars to repair. Simek made a motion to sign the certification. Sand seconded. Motion carried.

KLJ Engineer Bryan Tykwinski and Highway Superintendent Jeff Hagen joined the meeting at 11:00.

The interview committee presented a memo to the Commission on the selection of the preliminary and design engineering for the CER-1104(061) project. The committee is recommending the hiring of KLJ from this project. Both firms interviewed were very capable of completing the job. The decision to go with KLJ was because of their history with this project. Based on the recommendation of the interview committee, Hamar made a motion to approve the hiring of KLJ for this project. Roberts seconded. Motion carried

Tykwinski presented an estimate for the repair of county road 3 east of Oakes to the cemetery in the amount of \$314,311.39. The county share would be \$62,862.28 and would take a full year of federal funds to complete the project. With the CER-1104(061) project next year, there is not enough in the road budget to do this project. Discussion followed concerning what our highest priority should be with federal funds. Tykwinski would do some testing on County Road 8 an County Road 10 so that a decision could be made as to priority for the future.

Tykwinski presented a report to the Commission for an explanation of gravel and how it is graded.

Hamar made a motion to open the propane bid hearing. Sand seconded. Motion carried. Sheppard opened the one bid received from Farmers Union Oil Company in the amount of .85 per gallon for 20,000 gallons more or less for the period of January 1<sup>st</sup> through December 31<sup>st</sup>, 2021. Simek made a motion to accept the bid from Farmers Union. Sand seconded. Motion carried.

Hamar made a motion to close the bid hearing. Sand seconded. Motion carried Health Administrator Roxanne Holm joined the meeting at 12:03 to update the Commission on COVID-19 in Dickey County.

Sheppard presented information to the Commission on a fraud risk assessment that the State Auditor's office is requiring. This is an expectation of all counties that the State Auditors work with.

Discussion followed concerning the size of a committee to complete this assessment. Hamar made a motion to form the committee of employees to complete the assessment. Sand seconded. Motion carried. A decision was made to request assistance from Treasurer Wonada Lematta, Deputy Recorder Kelly Schmidt, Veterans Service Officer Gary Dathe, along with Auditor Sheppard to complete the assessment and to report back to the County Commissioners.

Estes presented the contract for jail services with Stutsman County. The daily rate increased from \$70 to \$75 per date per inmate. Hamar made a motion to sign the agreement. Simek seconded. Motion carried.

Estes presented a commercial lease for the RMK Operations building on Main Street. The Sheriff's office would use the space while the basement project is under construction. The agreement is for \$500/month for the front area of the building, on a month by month basis. RMK will pay for the utilities and Dickey County would need to carry insurance on any equipment they have in the building. Sand made a motion to sign the lease agreement. Hamar seconded. Motion carried.

Estes spoke with the Commission about storage containers that are available at ND Surplus Property for \$750 to store equipment and evidence they are required to hold. A decision was made to purchase the two storage containers at ND Surplus.

Simek made a motion to adjourn the meeting at 12:35.
