NOTICE OF LOCAL EQUALIZATION MEETINGS

NDCC § 57-02-51 requires that equalization proceedings in a city must be held within the first fifteen days of April & the equalization proceedings in an organized township must be held in the month of April at the regular meeting place of the governing board or other place designated by that board of the township or city, as the case may be. Each taxpayer has the right to appear before the appropriate board of review or equalization and petition for correction in the taxpayer's assessment.
