Commission Meeting

September 6, 2016

Chairman Sand called the meeting to order at 9:00. Present were Commissioners Joel Hamar, John Hokana, JT Homan, Dean Simek and Chairman Sand.

Additions to the Agenda

Tax Director

Mertz Construction

Deputy Treasurer Cheryl Brokaw joined the meeting at 9:45.

Simek said Gary Mertz, representing Mertz Construction, said the cost of fill was not included in the Mertz Lumber bid for the new Health District building and should have been the county's responsibility.

Chairman Sand reported he received complaints about the arrow sign around the curve on the Forbes road. Discussion followed. No action was taken.

Hamar motioned to approve the August 16 Commission Meeting minutes and the August 9th Special Budget Meeting minutes. Simek seconded. Motion carried.

Homan motioned to approve the voucher with the inclusion of the Game and Fish voucher in the amount of \$3,719. Hamar motioned to have the Chairman sign the Department of Transportation Certification paperwork for projects #CER 1112-064 and CER 1112 (065) on County 3. Simek seconded. Motion carried.

Tax Director Flaherty joined the meeting at 9:50 to present paperwork describing the properties the commission is considering contracting with Vangard for appraisal. The cost to do the reassessment will be \$52,000 to \$55,000 and the work will not be performed until 2019. Discussion followed about the possibility of having some smaller properties assessed locally. Homan motioned to hire Vangard to reassess the complex commercial properties. Simek seconded. Motion carried. The commission will budget a portion of the cost each year to spread the cost over a period of time.

Hamar motioned to approve the June 6 Equalization Meeting Minutes. Simek seconded.

Road Superintendent Jeff Hagen and 911/DES Director Charlie Russell joined the meeting at 10:55. Russell reported the Oakes City request for the county to pay a contract with Hexagon Safety and Infrastructure Contract t for I Mobile CC has been added to the 2017 budget.

Spencer Deering joined the meeting at 10:26 am. KLJ engineer Josh Loegering and Sheriff Chris Estes joined the meeting at 11:10. Mr. Deering Explained that he plans to clean accumulated silt from a portion of the ditch along County 3 to allow water flow, He requested permission to go into the DC Right of Way. Deering said he had approval from NRCS and FSA. Discussion followed. Hamar motioned to allow Mr. Deering to go ahead as long as the NRCS and FSA are OK with Deering's plan. In addition the stipulations that Dickey County will be held blameless of any activity: Deering is aware of location of fiber optics; the ditch is restored to its original condition and there will be at no expense to Dickey County . Simek seconded. Motion carried.

Kadrmas Lee and Jackson Engineer Loegering presented a photo of the north courthouse parking lot with lines added to show proposed parking areas. Discussion followed.

Loegering submitted project estimate #4 to pay the contractor for a portion of the County 3 widening. Simek motioned to pay project estimate #4 in the amount of \$177,072.98 to KD Hoyt. Hokana seconded. Motion carried.

Hagen presented a utility permit for Chairman Sand to sign. The permit is to bore under County 8 to lay drain tile.

The commission scheduled a Special Budget Hearing for 9:00 am on Friday, September 9th

Hokana motioned to adjourn the meeting at 1:20 P.M. Homan seconded. Motion carried.

Commission Meeting

September 20, 2016

Chairman Sand called the meeting to order at 9:00 am. Present were Commissioners Joel Hamer, John Hokana, JT Homan, Dean Simek and Chairman Sand. Also in attendance was Deputy Auditor Wanda Sheppard.

Ms. Sheppard said that Health District Director Roxanne Holm made changes to the Health District budget, which is now at 2.9 mills.

Commissioner Hamar left the meeting at 10:00 am due to prior commitments.

Homan motioned to approve the minutes with corrections. Simek seconded.

Simek motioned to approve the vouchers. Hokana seconded. Motion carried.

Hokana motioned to approve the financial statement. Homan seconded. Motion carried.

Sheriff Estes joined the meeting at 9:55 am. He discussed the coalition between the sheriff's offices in other states to assist each other with out of state prisoner transfers. The commissioners and Sheriff Estes discussed hiring a fourth deputy for patrol and truck regulatory duties. A fulltime position was added to the Sheriff budget.

Treasurer Gail Veland said the credit card fees have increased. The current fee to use a credit card is 2.5%. It is increasing 2.95% and Ms. Veland asked if the county can continue to charge the fee to the user. After discussion, the commission felt the fee should be charged to the credit card user.

Assistant Custodian Ray Peterson joined the meeting at 10:25 and asked if his 2017 budget could be increased \$400 for tree trimming. Mr. Peterson said there are some trees that are diseased and need to be removed.

Tax Director Don Flaherty joined the meeting at 10:30 am and told the commissioners that Vanguard has reconsidered their quote to assess the complex commercial properties in the county. Vanguard will remain at \$47,250 as the quoted in 2016. The completion date the assessments will be will remain at 2019 for the 2020 assessment year. Flaherty said unless States Attorney Neuharth finds errors or necessary changes Flaherty will have a contract for the Chairman to sign.

Flaherty updated the commission on the Harris Machine appeal and discussed some commercial sales that they cited to support their request for a reduction of value. Flaherty is providing information to the state tax office. He asked if the commission has any questions on the process he is discussing with them. He informed the board that the owner can take the same action on an annual basis.

Kadrmas, Lee and Jackson Engineer Josh Loegering, Highway Superintendent Jeff Hagen and 911/DES Manager Charles Russell joined the meeting at 11:00 am.

Commissioner Hokana told Russell of the commissioner's decision to make the FEMA Assistant Position a part time position until a time when FEMA activity mandates more hours. Russell agreed work load has slowed down. He said that the 2011 FEMA audit has been postponed indefinitely.

Josh Loegering said the borrow pit that was used for the County 3 widening project was measured and less borrow material was needed than originally expected. The engineers and contractors reported the angle of the ditch and the amount of borrow was good.

Loegering presented a change order from Central Specialties Industries (CSI). He said KD Hoyt originally bid the work for \$8,600 and later decided they didn't want to deal with the intersection. Simek motioned to have the Chairman sign the change order. Homan seconded. Motion carried.

Loegering submitted a pay estimate for KD Hoyt in the amount of \$244,116. Hokana motioned to sign the pay estimate. Homan seconded. Roll call vote passed with Hokana yes, Homan yes, Simek yes, and Sand yes.

Loegering said there will be a small fee from KLJ to survey the parking lot to assure the angles of the parking space lines are painted accurately.

Hagen submitted a request from SE Water Users to build an 8x10 storage building for chlorine. The structure will be located slightly inside 200 foot county right of way. Hokana motioned to grant SE Water Users the variance request because the building is located on the east side and the property owned by SE Water Users is limited. Simek seconded. Motion carried.

Homan motioned to accept the 2017 budget as presented. Hokana seconded. Motion carried.

The commissioners thanked Deputy Auditor Wanda Sheppard and those who assisted in completing the 2017 budget.

Hokana motioned to adjourn the meeting at 12:15 pm. Homan seconded. Motion carried.
